



*BAC Resolution No. 2024-0212-126 (Bravo)*

**SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SELCAL SOFTWARE UPGRADE AT PHILIPPINE ATMC**

**WHEREAS**, the project, SELCAL Software Upgrade at Philippine ATMC, an ANS project was forwarded to the Bids and Awards Committee- Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Fifteen Million Nine Hundred Fifty-Nine Thousand One Hundred Ninety-One Pesos and 36/100 Only (Php15,959,191.36). A copy of the Certificate of Budget Allocation CBA (MOOE) 24-03-420 dated 27 March 2024 is herein attached as *Annex "A"*;

**WHEREAS**, the Change/Determination of Mode was conducted on 15 May 2024 where the end-user requested for the Change of Mode of Procurement from Competitive Bidding to Direct Contracting as stated in Section 50 of the 2016 Revised Implementing Rules and Regulations. The change of mode was approved by the Committee. A copy of the Minutes of the Meeting is hereto attached as *Annex "B"*;

**WHEREAS**, the Committee issued a Request for Quotation to Rohde & Schwarz (Philippines) Inc. on 21 June 2024 for the Notice for Direct Contracting. A copy of the Notice of Direct Contracting is hereto attached as *Annex "C"*;

**WHEREAS**, the Submission and Opening of bids for the project was held on 5 July 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "D" & "E", respectively*;

**WHEREAS**, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 17 July 2024. On the same date, the BAC-Bravo TWG presented its report indicating that Rohde & Schwarz (Philippines) Inc. was determined legally, technically, and financially capable to deliver the goods at the most advantageous price and contract, under Sec 50.c of RA 9184. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "F" & "G", respectively*;

**WHEREAS**, **Section 50 of RA 9184** it provides that *Direct Contracting or single source procurement is a method of procurement of Goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale. The offer may be accepted immediately or after some negotiations. Direct contracting may be resorted to by concerned Procuring Entities under any of the following conditions:*



*Sec 50.c- "Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.;*

**NOW THEREFORE**, premises considered, the **CAAP-BAC BRAVO RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** through **Direct Contracting** of the project, **SELCAL Software Upgrade at Philippine ATMC** in the total amount of **Fifteen Million Nine Hundred Fifty-Nine Thousand One Hundred Ninety-One Pesos and 36/100 Only (Php15,959,191.36)** to **Rohde & Schwarz (Philippines) Inc.;**
