



BAC Resolution No. 2024-0910-179 (Bravo)

SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, SUPPLY, DELIVERY, INSTALLATION, AND COMMISSIONING OF FIRE SUPPRESSION SYSTEM FOR THE MISD DATA CENTER (REBID).

WHEREAS, the project Supply, Delivery, Installation, and Commissioning of Fire Suppression System for the MISD Data Center (Rebid), an ODG-CORPLAN project was forwarded to the Bids and Awards Committee – Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Three Million Pesos (PHP3,000,000.00). A copy of the Certificate of Budget Allocation CBA (C.O) No. 24-01-125 dated 31 January 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 10 July 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 18 July 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, the Pre-Bid Conference was conducted on 26 July 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 09 August 2024 at the CAAP Conference Room and via video conference. Bidders submitted their bid proposals for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "E" & "F"*, respectively;

WHEREAS, the Bids and Awards Committee Technical Working Group – Bravo (BAC TWG - Bravo) issued its Bid Evaluation Report dated 16 August 2024 and was presented to the BAC on the same day, where it is indicated that the bid proposal of Global Trends & Infrastructure Technologies, Inc. is recommended to be declared as Single Calculated Bid (SCB) in the amount of Two Million Two Hundred Ninety-Three Thousand Two Hundred Thirty-Two Pesos (PHP2,293,232.00) and subject its bid proposal for Post-Qualification. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "I" & "J"*;

WHEREAS, the Committee issued a letter to Global Trends & Infrastructure Technologies, Inc. dated 16 August 2024, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "K"*;

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 11 September 2024 and was presented to the BAC on the same day, wherein the BAC TWG (Bravo) recommended that the bid proposal of Global Trends & Infrastructure Technologies, Inc. be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of Two Million Two Hundred Ninety-Three Thousand Two Hundred Thirty-Two Pesos (PHP 2,293,232.00). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "L" & "M"*;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;*

NOW, THEREFORE, premises considered, the **CAAP-BAC (BRAVO) RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, Supply and Installation of Supply, Delivery, Installation, and Commissioning of Fire Suppression System for the MISD Data Center (Rebid) in the total amount of Two Million Two Hundred Ninety-Three Thousand Two Hundred Thirty-Two Pesos (**PHP 2,293,232.00**) to **Global Trends & Infrastructure Technologies, Inc.**
