## CCC Resolution No. 2024-052

SUBJECT:

SUPPLY AND DELIVERY OF 14 PIECES 1000W, 120V PAR64 AERODROME BEACON BULBS FOR VARIOUS AIRPORTS.

WHEREAS, Purchase Request/POW/CBA No. 24-02-279 dated 27 February 2024 for the Supply and delivery of 14 pieces 1000W, 120V PAR64 Aerodrome Beacon Bulbs for various Airports with a total budget of P399,000.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as Annex A;

WHEREAS, on 13 March 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". WHEREAS, CCC Resolution No. 2024-028 dated 24 May 2024 was signed for failure and reposting/rebidding. Copy of the Resolution hereto attached as **Annex C**;

WHEREAS, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 23 July 2024, Copy of PhilGeps postings hereto attached as **Annex D**;

WHEREAS, the Request for Quotation (RFQ) was sent to the following:

**WHEREAS**, during the opening of the sealed quotations held on 26 July 2024 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

**WHEREAS,** Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply and delivery of 14 pieces 1000W, 120V PAR64 Aerodrome Beacon Bulbs for various Airports in the total amount of TWO THOUSAND EIGHT HUNDRED PESOS (P2,800.00) only, and be AWARDED to Evercon Builders and Equipment Corporation, the offer of which was considered reasonable and advantageous to the Government;
