



SUBJECT: RECOMMENDING THE AWARD OF THE PROJECT ENTITLED, SUPPLY AND DELIVERY OF 6.6A PREFOCUS HALOGEN AFLS BULBS FOR VARIOUS AIRPORTS (SINGLE YEAR FRAMEWORK AGREEMENT)

WHEREAS, the project, Supply and Delivery of 6.6A Prefocus Halogen AFLS Bulbs for Various Airports (Single-Year Framework Agreement), an ANS project was forwarded to the Bids and Awards Committee – Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Eight Million Seven Hundred Seventy-Eight Thousand Seven Hundred Fifty Pesos (PHP8,778,750.00). A copy of the Certificate of Budget Allocation CBA (C.O) No. 24-04-479 dated 17 April 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 24 June 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 18 July 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, the Pre-Bid Conference was conducted on 26 July 2024 via in-person meeting and Google Meet Video Conference. A copy of tMinutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, The Committee received a letter of inquiry from Evercon Builders and Equipment Corporation on 29 July 2024. A copy of the letter of inquiry is hereto attached as *Annex "E"*

WHEREAS, Bid Bulletin 01 dated 31 July 2024 was issued for some clarification/revision/amendments in the bidding documents of the project. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "F"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 09 August 2024 at the CAAP Conference Room and via video conference. Bidders submitted their bid proposals for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "G" & "H", respectively*;

WHEREAS, the Bids and Awards Committee Technical Working Group – Bravo (BAC TWG - Bravo) issued its Bid Evaluation Report dated 14 August 2024 and was presented to the BAC on the same day, where it is indicated that the bid proposal of AGI Capital Ventures Inc. is recommended to be declared as Lowest Calculated Bid (LCB) in the amount of Seven Million Seventy-Four Thousand Four Hundred Pesos (Php7,074,400.00) and subject its bid proposal for Post-Qualification. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "I" & "J" respectively*;





WHEREAS, the Committee issued a letter to AGI Capital Ventures Inc., Inc. dated 14 August 2024, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "K"*;

WHEREAS, the Committee issued a Notice of Postponement dated 28 August 2024, rescheduling the meeting for all agenda items, including the presentation of the Post-Qualification Report for aforementioned project, to 29 August 2024. A copy of a Notice of Postponement is hereto attached as *Annex "L"*;

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 28 August 2024 and was presented to the BAC on 29 August 2024, wherein the BAC TWG (Bravo) recommended that the **Post-Disqualification** of the bid proposal of **AGI Capital Ventures Inc.** for the following grounds: (a) failure to disclose on-going contracts, (b) non-responsive Single Largest Completed Contract (SLCC) due to failure to meet the similarity of the contract requirement, and (c) non-responsive Conformity with the Technical Specifications for failure to provide the supporting documentation in their compliance statement. For the bid proposal of **Evercon Builders and Equipment Corporation** to undergo **Post-Qualification** in the amount of **Eight Million Five Hundred Eighteen Thousand Eight Hundred Eighty (Php8,815,880.00)**. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "M" & "N" respectively*;

WHEREAS, a Notice of Post-Disqualification dated 30 August 2024 was sent to AGI Capital Ventures Inc. informing them of their disqualification. A copy of the notice of disqualification is hereto attached as *Annex "O"*;

WHEREAS, the Committee issued a letter to Evercon Builders and Equipment Corporation dated 30 August 2024, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "P"*;

WHEREAS, the BAC-TWG issued its Post-Qualification Report dated 09 September 2024 and was presented to the BAC on the same day, wherein the BAC TWG (Bravo) recommended that the bid proposal of **Evercon Builders and Equipment Corporation** to be declared as the Lowest Calculated Responsive Bidder (LCRB) in the amount of **Eight Million Five Hundred Eighteen Thousand Eight Hundred Eighty (Php8,815,880.00)**. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "Q" & "R" respectively*;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.*;

NOW, THEREFORE, premises considered, the **CAAP-BAC (BRAVO) RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, Supply and Delivery of 6.6A Prefocus Halogen AFLS Bulbs for Various Airports (Single-Year Framework Agreement) in the total amount of **Eight Million Five Hundred Eighteen Thousand Eight Hundred Eighty (Php8,815,880.00)** to **Evercon Builders and Equipment Corporation**.
