SUBJECT:

ANNUAL SUBSCRIPTION OF AUTOCAD PROGRAM FOR AIS OPERATIONS.

WHEREAS, Purchase Request/POW/CBA No. 24-05-688 dated 29 May 2024 for the Annual Subscription of AutoCAD Program for AIS Operations with a total budget of P92,000.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as Annex A;

WHEREAS, on 18 September 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". WHEREAS, BAC Resolution No. 2024-0212-92 dated 24 June 2024 was signed for the change of mode of procurement. Copy of the Resolution hereto attached as **Annex C**;

WHEREAS, the Request for Quotation (RFQ) was posted twice at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 24 September 2024 and 05 October 2024 respectively, no quotation was received by the CCC Secretariat. The project was re-posted on 12 October 2024, Copy of PhilGeps postings hereto attached as Annex D;

WHEREAS, the Request for Quotation (RFQ) was sent to the following:

- 3. INFINITE MINDS;
- 4. CCP COMPUTER TECHNOLOGIES INC.;
- 5. FIRST DATA CORP.;

- 7. AGILE TECHFRONTIER CORPORATION;

WHEREAS, during the opening of the sealed quotations held on 18 October 2024 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

1. CIM TECHNOLOGIES, INC.	P82,000.00
2. EPARTNERS SOLUTIONS INC.	P90,873.00

WHEREAS, the end-user evaluation report submitted on 28 October 2024 disclosed that CIM TECHNOLOGIES, INC. complied with all CAAP requirements and specifications and is considered the lowest calculated and responsive quotation. Copy of the Evaluation hereto attached as **Annex E**;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Annual Subscription of AutoCAD Program for AIS Operations in the total amount of EIGHTY-TWO THOUSAND PESOS (P82,000.00) only, and be AWARDED to CIM TECHNOLOGIES, INC., the offer of which was considered reasonable and advantageous to the Government;
