THIS AGREEMENT entered this _____ between

called "CAAP" and represented herein by **CAPTAIN MANUEL ANTONIO L. TAMAYO** in his
capacity as Director General of the one part:

LSERV CORPORATION, a corporation organized and existing by virtue of law and with
office address at 21/F Petron Mega Plaza Building 358 Sen. Gil Puyat Avenue, Makati City
hereinafter called "the Supplier" and represented herein by **JOSEPH V. ANGELES** in his
capacity as President of the other part.

WHEREAS, CAAP requested quotation for certain ancillary services, particularly the
*Extension of the Manpower Outsourcing Contract Agreement of CAAP and LSERV
Corporation to Provide Professional and General Services Requirements in CAAP Central
Office and Area Centers for the period of 01 October 2024 to 31 December* and has accepted
the Quotation by the Supplier for the supply of those services in the sum of **ONE HUNDRED
FORTY-SIX MILLION EIGHT HUNDRED EIGHTEEN THOUSAND SIX HUNDRED SIXTY-SIX
PESOS & 83/100 ONLY (Php146,818,666.83)** hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:

3. In consideration of the sum of **ONE HUNDRED FORTY-SIX MILLION EIGHT HUNDRED
EIGHTEEN THOUSAND SIX HUNDRED SIXTY-SIX PESOS & 83/100 ONLY (PHP146,818,666.83)** or
such other sums as may be ascertained, **LSERV CORPORATION**, agrees to service the
*Extension of the Manpower Outsourcing Contract Agreement of CAAP and LSERV Corporation to
provide Professional and General Services Requirements in CAAP Central Office and Area Centers
for the period of 01 October 2024 to 31 December 2024* in accordance with his/her/its Bids.

4. In consideration of the provision of the services within **01 October 2024 to 31 December 2024** and the remedying of defects thereof, CAAP hereby covenants to pay the supplier the Contract Price or such other sum as may become payable under the provision of the Agreement at the times in the manner prescribed by this Agreement.
