## CCC Resolution No. 2024-081

SUBJECT:

PREVENTIVE MAINTENANCE OF FIRE ALARM AND FIRE SUPPRESSION DEVICES AT MANILA CNS/ATM FACILITY FOR ONE (1) YEAR.

WHEREAS, Purchase Request/POW/CBA No. 24-05-0665 dated 22 May 2024 for the Preventive Maintenance of Fire Alarm and Fire Suppression Devices at Manila CNS/ATM Facility for One (1) Year with a total budget of P999,660.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 18 September 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". WHEREAS, BAC Resolution No. 2024-0212-127 dated 05 August 2024 was signed for the change of mode of procurement. Copy of the Resolution hereto attached as Annex C;

WHEREAS, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 24 September 2024, Copy of PhilGeps postings hereto attached as **Annex D**;

WHEREAS, the Request for Quotation (RFQ) was sent to the following:

- 1. IHUDYAT INCORPORATION;
- 2. TOTAL FIRESAFETY AND TECHNOLOGIES INC.;
- 3. DELTAMAX TECHNOLOGY INC.; and
- 4. FIRE SOLUTIONS INC.;

**WHEREAS**, during the opening of the sealed quotations held on 27 September 2024 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

**WHEREAS,** Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL the Preventive Maintenance of Fire Alarm and Fire Suppression Devices at Manila CNS/ATM Facility for One (1) Year in the total amount of NINE HUNDRED TWENTY THOUSAND PESOS (P920,000.00) only, and be AWARDED to FIRE SOLUTIONS INC., the offer of which was considered reasonable and advantageous to the Government;
