



BAC Resolution No. 2024-0910-223 (Bravo)

SUBJECT: RECOMMENDING THE AWARD OF THE PROJECT ENTITLED, PURCHASE AND INSTALLATION OF COMMUNICATIONS EQUIPMENT FOR LAOAG INTERNATIONAL AND CAUAYAN AIRPORTS

WHEREAS, the project Purchase and Installation of Communications Equipment for Laoag International and Cauayan Airports, an ANS project, was forwarded to the Bids and Awards Committee – Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of **Seventy-Two Million Nine Hundred Ninety-Three Thousand Seven Hundred Seventeen Pesos & 28/100 (Php 72,993,717.28)**. A copy of the Certificate of Budget Allocation CBA (C.O) No. 24-02-266 dated 22 February 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 10 July 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 25 July 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, the Pre-Bid Conference was conducted on 02 August 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, Bid Bulletin No. 05 dated 25 September 2024 was issued re-scheduling the Submission and Opening of Bids. A copy of Bid Bulletin No.05 is hereto attached as *Annex "K"*;

WHEREAS, Bid Bulletin No. 06 dated 08 October 2024 was issued for some clarification/revision/amendments in the bidding documents of the project. A copy of Bid Bulletin No. 06 is hereto attached as *Annex "L"*;

WHEREAS, Bid Bulletin No. 07 dated 08 October 2024 was issued re-scheduling the Submission and Opening of Bids. A Copy of Bid Bulletin No. 07 is hereto attached as *Annex "M"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 21 October 2024 at the CAAP Conference Room and via video conference. Bidders submitted their bid proposals for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "N" & "O"*, respectively;

WHEREAS, the Bids and Awards Committee Technical Working Group – Bravo (BAC TWG - Bravo) issued its Bid Evaluation Report dated 30 October 2024 and was presented to the BAC on the same day, where it is indicated that the bid proposal of Evercon Builders and Equipment Corp. is recommended to be declared as Single Calculated Bid (SCB) in the amount of Sixty-Eight Million Three Hundred Eighty-Eight Thousand Eight Hundred (Php 68,388,800.00) and subject its bid proposal for Post-Qualification. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "P" & "Q"* respectively;

WHEREAS, the Committee issued a letter to Evercon Builders and Equipment Corp. dated 30 October 2024, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "R"*;





WHEREAS, the BAC TWG (Bravo) issued its Post-Qualification Report dated 13 November 2024 and presented it to the BAC Committee (Bravo) on the same date, wherein the BAC TWG (Bravo) recommended that the bid proposal of **Evercon Builders and Equipment Corp.** be declared as the Single Calculated and Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of **Sixty-Eight Million Three Hundred Eighty-Eight Thousand Eight Hundred Pesos (Php 68,388,800.00)**. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "S" & "T", respectively*;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;*






