- 1. All entries must be printed.
- 2. Number of days to complete: Twenty-One (21) Calendar Days specifically, Three (3) PMS Schedule, Seven (7) Calendar Days Per PMS Schedule.
- 3. Bid must be complete and award will be made on a lump sum basis.
- 4. Price validity shall be for a period of thirty (30) calendar days.
- 5. The following should be submitted together with the quotation:
 - 5.1 Current Mayor's/Business Permit;
 - 5.2 Phil-GEPS Registration Number;
 - 5.3 List of completed similar project within the last five (5) years which must be related to installation and/repair of any auto sliding doors with attached supporting documents;
 - 5.4 List of Contractor's Equipment, including proof of ownership or certification of availability of the Basic Tools, Special Tools, and ladder from the lessor/vendor for the duration of the project, as the case may be; and
 - 5.5 Name/credentials of proposed three (3) Service Technical Personnel and one (1) Assistant Technician/Helper;
- 6. Other documentary requirements:
 - 6.1 Omnibus Sworn Statement (see attached format, maybe submitted together with the quotation or before issuance of Notice of Award.)
 - 6.2 Latest Income & Business Tax Returns

- 6.2.1 Latest Income Tax Return (ITR) shall be the ITR for the preceding year, whether calendar or fiscal duly stamped received by the BIR; and
- 6.2.2 Latest Business Tax Returns shall refer to the Value Added Tax (VAT) or Percentage Tax filed and paid covering the previous six (6) months before the date of Submission, Receipt, Opening & Preliminary Examination of Bids filed through the Electronic Filing & Payment System (EFPS).

Quotations not accompanied by current Mayor's/Business Permit; Phil-GEPS Registration Number; Name/credentials of proposed Service Technical Personnel and Assistant Technician/Helper ; List of completed similar project; and List of Contractor's Equipment, including proof of ownership or certification of availability of Basic Tools, Special Tools, and Ladder from the lessor/vendor for the duration of the project, as the case may be, shall be automatically disqualified.

Quotations will be opened in the presence of the Bidders' representatives who choose to attend at the address below. **Online submission is not allowed and late quotations shall not be accepted.**

Your prices must be quoted in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental cost to the delivery site if the contract is awarded.
