RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION, TESTING AND COMMISSIONING OF STAND-ALONE CCTV SURVEILLANCE SYSTEM FOR

**VARIOUS RADAR SITES (8 SITES)** 

**WHEREAS**, the project, Supply, Delivery, Installation, Configuration, Testing and Commissioning of Stand-Alone CCTV Surveillance System for Various Radar Sites (8 Sites), an CSIS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to **Fourteen Million Nine Hundred Ninety-Six Thousand Seven Hundred Sixty-Four Pesos & 80/100 (Php 14,996,764.80).** A copy of the Certificate of Budget Allocation (CBA (CO) No. 24-08-985 dated 03 August 2024) is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 23 September 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 14 October 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS**, the Pre-Bid Conference was conducted on 21 October 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

**WHEREAS**, the Bid Bulletin No. 01 dated 28 October 2024 was issued for the new schedule of the Submission and Opening of Bids. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "E"*;

**WHEREAS**, the Submission and Opening of Bids for the project was held on 13 November 2024 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. **WHEREAS**, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 27 November 2024 and was presented to the BAC on the same day, wherein the BAC TWG (Bravo) recommended that the bid proposal of Annex Digital Inc. be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of Fourteen Million Nine Hundred Eighty-Eight Thousand Pesos (PHP 14,988,000.00). **WHEREAS,** Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend* to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;

NOW, THEREFORE, premises considered, the CAAP-BAC (BRAVO) RESOLVES, as it is hereby RESOLVED to recommend the APPROVAL and AWARD of the project, Supply, Delivery, Installation, Configuration, Testing and Commissioning of Stand-Alone CCTV Surveillance System for Various Radar Sites (8 Sites) in the total amount of Fourteen Million Nine Hundred Eighty-Eight Thousand Pesos (PHP 14,988,000.00) to Annex Digital Inc.
