



BAC Resolution No. 2024-0910-214 (Bravo)

SUBJECT: RECOMMENDING THE AWARD OF THE PROJECT ENTITLED, SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF PRECISION AIR-CONDITIONING UNIT FOR MISD DATA CENTER

WHEREAS, the project Supply, Delivery, Installation and Commissioning of Precision Air-Conditioning Unit for MISD Data Center, an ODG/MISD Corplan project, was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of **Two Million Pesos (Php2,000,000.00)**. A copy of the Certificate of Budget Allocation CBA (C.O.) #24-01-126, dated 31 January 2024, is attached hereto as *Annex "A"*;

WHEREAS, BAC Resolution 2024-0212-102 dated 15 June 2024 and BAC Resolution 2024-0212-140 dated 15 August 2024 declared the project, a failure. The copies of the Resolutions are hereto attached as *Annex "B"*;

WHEREAS, the Pre-Procurement Conference was conducted on 30 September 2024 via in-person meeting and Google Meet Video Conference wherein the end-user recommends the Change of Mode of Procurement of the project from Competitive Bidding to Negotiated Procurement due to two failed biddings. A copy of the Minutes of Meeting is hereto attached as *Annex "C"*;

WHEREAS, Sec 53 of the IRR of RA 9184 provides that: *Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects, and Consulting services, whereby the Procuring Entity directly negotiates a contract with a technically, legally, and financially capable supplier, contractor, or consultant in any of the following cases: (a) Two Failed Biddings. Where there has been a failure of competitive bidding or Limited Source Bidding for the second time as provided in Section 35 of the Act and this IRR.;*

WHEREAS, the Committee sent Negotiation Letters to prospective bidders. The copies of the Negotiation letters are hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of bids for the project was held on 28 October 2024 at the CAAP Conference Room via in-person meeting and video conference. A lone bidder submitted its bid proposal for the project and the following results were noted. The copies of the Minutes of the Meeting and Abstract of Bids as read are hereto attached as *Annexes "E" & "F"*, respectively;

WHEREAS, the BAC Technical Working Group (Bravo) issued its Bid Evaluation Report, dated 30 October 2024, and presented it to the BAC on the same date, indicating that the tendered bid proposal of **JS Aromatoc Communication Services** be declared as the Single Calculated and Responsive Bid (SCRB) in the amount of **One Million Five Hundred Thousand Pesos (Php 1,500,000.00)**. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "G" & "H"*, respectively;

WHEREAS, Section 37.1.1 of the 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of the contract to the bidder with the LCRB, HRRB, SCRБ, or SRRB after the post-qualification process has been completed;*

NOW, THEREFORE, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of the BAC-TWG (Bravo), hereby **RESOLVES** to **RECOMMEND TO AWARD THE CONTRACT** for the project **Supply, Delivery, Installation and Commissioning of Precision Air-Conditioning Unit for MISD Data Center** in the amount of **One Million Five Hundred Thousand Pesos (Php 1,500,000.00)** to **JS Aromatoc Communication Services**.
