CCC Resolution No. 2024-090

SUBJECT: SUPPLY AND DELIVERY OF CATGE UTP CABLE FOR VARIOUS ANF.

WHEREAS, Purchase Request/POW/CBA No. 24-08-1092 dated 30 August 2024 for the Supply and Delivery of CAT6E UTP Cable for various ANF with a total budget of P30,557.18 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 23 September 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". WHEREAS, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 05 October 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

WHEREAS, the Request for Quotation (RFQ) was sent to the following:

WHEREAS, during the opening of the sealed quotations held on 09 October 2024 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply and Delivery of CAT6E UTP Cable for various ANF in the total amount of TWELVE THOUSAND PESOS (P12,000.00) only, and be AWARDED to TRIPLE RG CONSUMER GOODS TRADING, the offer of which was considered reasonable and advantageous to the Government;
