**CCC Resolution No. 2024-091**

**SUBJECT: SUPPLY AND DELIVERY OF FIFTY (50) PIECES CONTROLLERS' TASK CHAIR FOR  
ATS FACILITIES AND OFFICES USE.**

**WHEREAS**, Purchase Request/POW/CBA No. 24-07-084 dated 01 July 2024 for the Supply and Delivery of fifty (50) pieces Controllers' Task Chair for ATS Facilities and Offices use with a total budget of P450,000.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

**WHEREAS**, on 18 September 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". **WHEREAS**, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 24 September 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

**WHEREAS**, the Request for Quotation (RFQ) was sent to the following:

**WHEREAS**, during the opening of the sealed quotations held on 27 September 2024 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

WHEREAS, the end-user evaluation report submitted on 21 October 2024 disclosed that PLANTATION SPORTS INC. did not comply with the technical specifications while LEE DESIGNS INDUSTRIES INC. complied with all CAAP requirements and specifications and is considered as the lowest calculated and responsive quotation. Copy of the Evaluation Report hereto attached as **Annex D**;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC **RESOLVES**, as it is hereby **RESOLVED** to recommend for **APPROVAL** of the Supply and Delivery of fifty (50) pieces Controllers' Task Chair for ATS Facilities and Offices in the total amount of **FOUR HUNDRED TWENTY-FIVE THOUSAND (P425,000.00)** only, and be **AWARDED** to **LEE DESIGNS INDUSTRIES INC.**, the offer of which was considered reasonable and advantageous to the Government;
