WHEREAS, CAAP requested quotation for certain good and ancillary services, particularly the Supply and delivery of spare parts for Indra DVOR/DME for Manila CNS Facility and has accepted the Quotation by the Supplier for the supply of those goods in the sum of TWO MILLION FOUR HUNDRED THOUSAND PESOS ONLY (Php2,400,000.00) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:

 - (2.7) BAC Resolution No. 2024-0910-164 (Bravo) dated 13 September 2024
 - (2.8) Notice of Award dated 20 September 2024
- 3. In consideration of the payments to be made by the Entity to the Supplier as herein mentioned, the Supplier hereby covenants with the Entity to provide the goods and services within Twelve to Fourteen (12 to 14) months from receipt of this contract and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The CAAP covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Agreement.
