AEROMEDICAL ADVISORY NO. 04-2024

**SUBJECT: REVISED SCHEDULE OF ROUTINE TEST REQUIREMENTS FOR THE
ISSUANCE OF VARIOUS CLASSES OF AVIATION MEDICAL
CERTIFICATES**

This Advisory is issued to inform all airmen applicants applying for issuance of initial and renewal of various Classes of Aviation Medical Certificates.

In view of process review and standard requirements, please be informed of the revised routine test requirements and shall be effective immediately.

A. CLASS 1 MEDICAL CERTIFICATE

A.1 INITIAL APPLICATION

Age	Initial Issue
39 years old and below	Eye examination, Dental examination, CBC, Urinalysis, Drug Test, Audiogram-Puretone, Chest Radiograph, ECG
40 years old and above	Eye examination, Dental examination, CBC, Blood chemistry, Urinalysis, Drug Test, Audiogram-Puretone, Chest Radiograph, Treadmill Stress Test-Bruce Protocol

A.2 RENEWAL

Specific Test	Schedule of Test
Eye and Dental Examination	Every renewal
CBC/Urinalysis	Every renewal



Blood Chemistry	Required upon reaching the applicant's 40 th birthday and annually thereafter but may vary to those cases that require monitoring
Audiogram	Required every 5 years from initial application but may vary to those cases that require monitoring
Chest Radiograph	Required annually
ECG	Required annually until the applicant's 39 th birthday
Treadmill Stress Test	Required upon reaching the applicant's 40 th birthday and annually thereafter but may vary to those cases that require monitoring

B. CLASS 2 MEDICAL CERTIFICATE

B1.1 INITIAL APPLICATION

Age	Initial Issue
39 years old and below	Eye examination, Dental examination, CBC, Urinalysis, Drug Test, Audiogram-Puretone, Chest Radiograph, ECG
40 years old – 49 years old	Eye examination, Dental examination, CBC, Blood chemistry, Urinalysis, Drug Test, Audiogram-Puretone, Chest Radiograph, ECG
50 years old and above	Eye examination, Dental examination, CBC, Blood chemistry, Urinalysis, Drug Test, Audiogram-Puretone, Chest Radiograph, Treadmill Stress Test-Bruce Protocol

B.2. RENEWAL

Specific Test	Schedule of Test
Eye and Dental Examination	Every renewal
CBC/Urinalysis	Every renewal
Blood Chemistry	Required upon reaching the applicant's 40 th birthday and every 2 years thereafter but may vary to those cases that require monitoring

Audiogram	Required every 5 years from initial application but may vary to those cases that require monitoring
Chest Radiograph	Required annually
ECG	Required annually
Treadmill Stress Test	Required every 5 years after reaching the applicant's 50 th birthday but may vary to those cases that require monitoring

C. CLASS 3 MEDICAL CERTIFICATE

C.1. INITIAL APPLICATION

Age	Initial Issue
39 years old and below	Eye examination, Dental examination, CBC, Urinalysis, Drug Test, Audiogram-Puretone, Chest Radiograph, ECG
40 years old and above	Eye examination, Dental examination, CBC, Blood chemistry, Urinalysis, Drug Test, Audiogram-Puretone, Chest Radiograph, Treadmill Stress Test-Bruce Protocol

C.2. RENEWAL

Specific Test	Schedule of Test
Eye Examination	Every renewal
CBC/Urinalysis	Every renewal
Blood Chemistry	Required upon reaching the applicant's 40 th birthday and annually thereafter but may vary to those cases that require monitoring
Audiogram	Required every 5 years from initial application but may vary to those cases that require monitoring
Chest Radiograph	Every renewal
ECG	Every renewal
Treadmill Stress Test	Required upon reaching the applicant's 40 th birthday and every 5 years thereafter but may vary to those cases that require monitoring

ROUTINE TEST REQUIREMENTS FOR AERONAUTICAL STATION OPERATOR (ASO)

Age	Initial Issue
34 years old and below	Eye examination, Dental examination, Urinalysis, CBC, Drug Test, Chest Radiograph, ECG, Neuro-Psychiatric Evaluation and Clearance
35 years old and above	Eye examination, Dental examination, Urinalysis, CBC, Blood chemistry, Drug Test, Chest Radiograph, ECG, Neuro-Psychiatric Evaluation and Clearance

Age	Renewal
34 years old and below	Eye examination, Urinalysis, CBC, Chest Radiograph, ECG
35 years old and above	Eye examination, Urinalysis, CBC, Blood Chemistry, Chest Radiograph, ECG
