RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF MEDICINE AND MEDICAL SUPPLIES AT EVELIO B. JAVIER (ANTIQUE) AIRPORT

WHEREAS, BAC Resolution No. AREA6-EBJ-SVP-2024-015-01 for the project Supply and Delivery of Medicine and Medical Supplies at Evelio B. Javier (Antique) Airport with Approved Budget for the Contract (ABC) in the amount of Thirty Thousand Nine Hundred Twenty Pesos & 10/100 (P 30,920.10) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Two (2) interested suppliers submitted its sealed quotation;

WHEREAS, during the Bid Opening last November 18, 2024, ECGA MEDICAL EQUIPMENT AND SUPPLIES TRADING was declared Single Submitted Quotation with the Bid amount of Thirty Thousand Eight Hundred Four Pesos (₱ 30,804.00);

WHEREAS, bid submitted by IGNACIO REBECCA GENERAL MERCHANT has been disqualified due to the bid amount exceeded the Approved Budget Contract as stated in the Request for Quotation Terms and Condition Item No. 8: "Quotations exceeding the Approved Budget of Contract shall be rejected."

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
