



BAC Resolution No. AREA6-SVP-2024-001-02

**RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF BIOMETRIC DEVICE FOR
AREA CENTER 6 AIRPORTS**

WHEREAS, BAC Resolution No. AREA6- SVP-2024-001-01 for the project **Supply and Delivery of Biometric Device for Area Center 6 Airports** with Approved Budget for the Contract (ABC) in the amount of **Two Hundred Thousand Pesos (P 200,000.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Five (5) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Five (5) interested suppliers submitted its sealed quotation;

WHEREAS, during the Bid Opening last November 22, 2024, **CYBERLINK COMPU SALES CORPORATION** was declared Lowest Submitted Quotation with the Bid amount of **One Hundred Eighty Four Thousand Pesos (P 184,000.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, bid submitted by the following bidders:

- a) **WINDEV INFORMATION TECHNOLOGY SOLUTIONS** has been disqualified during the bid opening due to Non-submission of eligibility requirements as stated in the Request for Quotation:

1. ***Omnibus Sworn Statement and***
2. ***Special Power of Attorney***

- b) **GPL TRADING OPC** has been disqualified during the bid opening due to:



- 1) Submitted Omnibus Sworn Statement was **NOT** duly notarized

In Section 25.3a of the 2016 revised IRR of RA No. 9184 states that *"The signatory is the duly authorized representative of the prospective bidder, and granted full power and authority to do, execute and perform any and all acts necessary to participate, submit the bid, and to sign and execute the ensuing contract accompanied by the **duly notarized** Special Power of Attorney, Board/Partnership Resolution, or Secretary's Certificate, whichever applicable."* and,

- 2) Non-submission of eligibility requirements as stated in the Request for Quotation:

a) Special Power of Attorney or Secretary's Certificate

- c) **IACS MARKETING COMPANY** has been disqualified during the bid opening due to Non-submission of eligibility requirements as stated in the Request for Quotation:

1. **Omnibus Sworn Statement and**
2. **Special Power of Attorney**

In Section 30.1. of the 2016 revised IRR of RA No.9184 *"The BAC shall open the first bid envelopes in public to determine each bidder's compliance with the documents required to be submitted for eligibility and for the technical requirements, as prescribed in this IRR. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed."*
