SUBJECT:

RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, ANNUAL **EUROPEAN AERONAUTICAL INFORMATION SERVICE DATABASE (EAD)**

PRO ADDITIONAL LICENSE

WHEREAS, the project, Annual European Aeronautical Information Service Database (EAD) Pro Additional License, an ATS project, was forwarded to the Bids and Awards Committee- Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Ten Million Eight Hundred **Thousand** Three Hundred Ninety-Three **Pesos** Ninety-Nine (PHP10,899,393.15). A copy of the Certificate of Budget Allocation CBA (MOOE) 24-03-328 dated 05 March 2024 is herein attached as Annex "A";

WHEREAS the Change/Determination of Mode was conducted on 29 November 2024 where the end-user requested for the Confirmation of Mode of Procurement be done through Direct Contracting stating the fact that there is only one service provider for the project a position substantiated by the submitted Apostille Certificate of Sole Distributorship, after reviewing the documents concurred. A copy of the Minutes of the Meeting is hereto attached as Annex "B";

WHEREAS, the Committee issued Notice of Direct Contracting and Request for Quotation No. 24-12-030 to Airnav Technology Services Inc. on 10 December 2024. A copy of the Notice of Direct Contracting and Request for Quotation is hereto attached as Annex "C";

WHEREAS, the Submission and Opening of bids for the project was held on 18 December 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as Annexes "D" & "E", respectively;

WHEREAS, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 23 December 2024. On the same date, the BAC-Bravo TWG presented its report indicating that Airnav Technology Services Inc. was determined legally, technically, and financially capable to deliver the goods at the most advantageous price and contract, under Sec 50.c of RA 9184. The copies of said Report and Minutes of Meeting are hereto attached as Annexes "F" & "G", respectively;





WHEREAS, Section 50 of RA 9184 it provides that Direct Contracting or single source procurement is a method of procurement of Goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale. The offer may be accepted immediately or after some negotiations. Direct contracting may be resorted to by concerned Procuring Entities under any of the following conditions:

Sec 50.c- "Those sold by an exclusive dealer or manufacturer which does not have subdealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.;

NOW THEREFORE, premises considered, the CAAP-BAC BRAVO RESOLVES, as it is hereby RESOLVED to recommend the APPROVAL and AWARD through Direct Contracting of the project, Annual European Aeronautical Information Service Database (EAD) Pro Additional License in the total amount of Ten Million One Hundred Thousand Pesos (PHP10,100,000.00) to Airnav Technology Services Inc.;
