**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL OF DISMANTLE OF THREE (3) UNITS FIVE (5) TR AIR-
CONDITIONING UNITS AT ILOILO INTERNATIONAL AIRPORT THEN TRANSFER AND
INSTALL TO DUMAGUETE AIRPORT**

WHEREAS, BAC Resolution No. BSVP-ILO 2024-072-01 for the project **Dismantle of Three (3) Units Five (5) TR Air-Conditioning Units at Iloilo International Airport then Transfer and Install to Dumaguete Airport** with Approved Budget for the Contract (ABC) in the amount of **Seventy Eight Thousand Pesos (₱ 78,000.00)** hereby form the integral part of this resolution.
