RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF GROCERY PACKS FOR THE YEAR – END THANKSGIVING CELEBRATION CY 2024 OF CAAP – ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-073-01 for the project Supply and Delivery of Grocery Packs for the Year – End Thanksgiving Celebration CY 2024 of CAAP – Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Six Hundred Thirty Two Thousand Pesos (P 632,000.00) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Three (3) interested suppliers submitted its sealed quotation;

WHEREAS, during the Bid Opening last December 10, 2024, CHE ENTERPRISES was declared Single Submitted Quotation with the Bid amount of Six Hundred Thirty One Thousand Eight Hundred Twenty Eight Pesos & 40/100 (P 631,828.40);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, bid submitted by the following bidders:

- a) NEW ILOILO IZEEM COMMERCIAL SUMMIT INC. has been disqualified due to the bid amount exceeded the Approved Budget Contract as stated in the Request for Quotation Terms and Condition Item No. 6: "Quotations exceeding the Approved Budget of Contract shall be rejected."
- **b) SUPER SHOPPING MARKET, INC.** has been disqualified due to Non-submission of eligibility requirements as stated in the Request for Quotation:
- 1. Business Permit,
- 2. Omnibus Sworn Statement,
- Annual Income Tax Return/Business Tax,

- 4. Tax Clearance,
- 5. PhilGEPS Certificate of Registration and
- 6. Special Power of Attorney for Sole Proprietorship/ Secretary Certificate for Corporation and Cooperative

In Section 30.1. of the 2016 revised IRR of RA No.9184 "The BAC shall open the first bid envelopes in public to determine each bidder's compliance with the documents required to be submitted for eligibility and for the technical requirements, as prescribed in this IRR. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed";

WHEREAS, the detailed evaluation of quotations conducted resulted in the following:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, **CHE ENTERPRISES** as found to be the Single Calculated Responsive Quotation;

NOW THEREFORE, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare, CHE ENTERPRISES as the Supplier with the Single Calculated Responsive Quotation for the project Supply and Delivery of Grocery Packs for the Year End Thanksgiving Celebration CY 2024 of CAAP Iloilo International Airport in the bid amount of Six Hundred Thirty One Thousand Eight Hundred Twenty Eight Pesos & 40/100 (*) 631,828.40);
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
