RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF FOOD PROVISION IN RELATION TO THE YEAR – END THANKSGIVING CELEBRATION CY 2024 OF CAAP – ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-074-01 for the project Food Provision in Relation to the Year – End Thanksgiving Celebration CY 2024 of CAAP – Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of One Hundred Fifty Eight Thousand Pesos (P 158,000.00) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Two (2) interested suppliers submitted its sealed quotation;

WHEREAS, during the Bid Opening last December 6, 2024, MAMBA BAR AND RESTAURANT was declared Single Submitted Quotation with the Bid amount of **One Hundred Fifty Thousand One Hundred Pesos** (**P** 150,100.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, bid submitted by **LUCILLA'S CATERING SERVICES**, **OPC** has been disqualified during the bid opening due to Non-submission of eligibility requirements as stated in the Request for Quotation:

- 1. Business Permit,
- 2. Omnibus Sworn Statement,
- PhilGEPS Certificate of Registration and
- Special Power of Attorney for Sole Proprietorship/ Secretary Certificate for Corporation and Cooperative

In Section 30.1. of the 2016 revised IRR of RA No.9184 "The BAC shall open the first bid envelopes in public to determine each bidder's compliance with the documents required to be submitted for eligibility and for the technical requirements, as prescribed in this IRR. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed";

- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
