RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF VRLA BATTERIES OF VARIOUS NAVIGATIONAL AIDS EQUIPMENT AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-075-01 for the project Supply and Delivery of VRLA Batteries of Various Navigational Aids Equipment at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of One Hundred Fifty Two Thousand Eight Hundred Thirty Four Pesos (P 152,834.00) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Three (3) interested suppliers submitted its sealed quotation;

WHEREAS, during the Bid Opening last December 16, 2024, P2RO, INC. was declared as the Single Submitted Quotation with the Bid amount of One Hundred Fifty Thousand Six Hundred Eight Pesos (**P** 150,608.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, bid submitted by AUTOMATION SPECIALISTS AND POWER EXPONENTS, INC. and TECHNICA SOLUTIONS INC. has been disqualified due to: Non-submission of eligibility requirements as stated in the Request for Quotation:

- 1. Omnibus Sworn Statement,
- 2. Special Power of Attorney for Sole Proprietorship/ Secretary Certificate for Corporation and Cooperative

In Section 30.1. of the 2016 revised IRR of RA No.9184 "The BAC shall open the first bid envelopes in public to determine each bidder's compliance with the documents required to be submitted for eligibility and for the technical requirements, as prescribed in this IRR. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

- a) To declare, P2RO, INC. as the Supplier with the Single Calculated Responsive Quotation for the project Supply and Delivery of VRLA Batteries of Various Navigational Aids Equipment at Iloilo International Airport in the bid amount of One Hundred Fifty Thousand Six Hundred Eight Pesos (**\$150,608.00**);
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
