



Contract Agreement

THIS AGREEMENT, made on JAN 28 2025 between **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES - AREA XI** of Davao City, Philippines (hereinafter called "the Entity") and **E.B. TESTING CENTER, INC.** of Davao City, Philippines (hereinafter called "the Contractor").

WHEREAS, the Entity is desirous that the Contractor execute "**CONDUCT OF CORING TEST AND CALIFORNIA BEARING RATIO TEST ON RUNWAYS, TAXIWAYS AND APRONS OF INTERNATIONAL, PRINCIPAL CLASS 1 AND PRINCIPAL CLASS 2 AIRPORTS AT AREA CENTER 11**" under Purchase Request No. 2024-12-654 (hereinafter called "the Works") and the Entity has accepted the Bid for **TWO HUNDRED SEVEN THOUSAND FIVE HUNDRED PESOS ONLY (₱ 207,500.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

A. Request For Quotation (RFQ) and the indicated Scope of Work therein;

B. Performance Security;

C. Notice of Award of Contract and the Bidder's conforme thereto; and

D. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **TWO HUNDRED SEVEN THOUSAND FIVE HUNDRED PESOS ONLY (₱ 207,500.00)**, **E.B. TESTING CENTER, INC.** agrees to implement and complete the project, "**CONDUCT OF CORING TEST AND CALIFORNIA BEARING RATIO TEST ON RUNWAYS, TAXIWAYS AND APRONS OF INTERNATIONAL, PRINCIPAL CLASS 1 AND PRINCIPAL CLASS 2 AIRPORTS AT AREA CENTER 11**" in accordance with his/her/its Bid.

4. The **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES - AREA XI** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




