Contract Agreement

THIS AGREEMENT, made on ________ between CIVIL AVIATION AUTHORITY OF THE PHILIPPINES - AREA XI of Davao City, Philippines (hereinafter called "the Entity") and E.B. TESTING CENTER, INC. of Davao City, Philippines (hereinafter called "the Contractor").

 - A. Request For Quotation (RFQ) and the indicated Scope of Work therein;
 - B. Performance Security;
 - C. Notice of Award of Contract and the Bidder's conforme thereto; and
 - D. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of TWO HUNDRED SEVEN THOUSAND FIVE HUNDRED PESOS ONLY (₱ 207,500.00), E.B. TESTING CENTER, INC. agrees to implement and complete the project, "CONDUCT OF CORING TEST AND CALIFORNIA BEARING RATIO TEST ON RUNWAYS, TAXIWAYS AND APRONS OF INTERNATIONAL, PRINCIPAL CLASS 1 AND PRINCIPAL CLASS 2 AIRPORTS AT AREA CENTER 11 in accordance with his/her/its Bid.
- 4. The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES AREA XI agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


