BAC Resolution No. 2024-0910-281 (Bravo)

SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, CONFIGURATION AND IMPLEMENTATION OF A 3-YEAR SUBSCRIPTION PLAN FOR A CLOUD ENTERPRISE RESOURCE PLANNING (ERP) SOLUTION FOR HUMAN RESOURCE, FINANCE AND ADMINISTRATIVE OPERATIONS OF THE CIVIL AVIATION AUTHORITY OF THE PHILIPPINES

WHEREAS, the project Configuration and Implementation of a 3-Year Subscription plan for a Cloud Enterprise Resource Planning (ERP) Solution for Human Resource, Finance and Administrative Operations of the Civil Aviation Authority of the Philippines, an ODG-CORPLAN/FD project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to **Three Hundred Fifty Million Pesos (PHP350,000,000.00)**. A copy of the Certificate of Budget Allocation (CBA (C.O) No. 24-10-1320 dated 22 October 2024) is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 28 October 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 08 November 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

WHEREAS, the Pre-bid Conference was conducted on 15 November 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, Bid Bulletin No. 01 was issued dated 21 November 2024 for the new schedule for the Submission and Opening of Bids. A copy of Bid Bulletin No.01 is hereto attached as *Annex "E"*;

WHEREAS, Bid Bulletin No. 02 was issued dated 26 November 2024 for some clarification/revision/amendments in the bidding documents of the project. A copy of Bid Bulletin No.02 is hereto attached as *Annex "F"*;

WHEREAS, Bid Bulletin No. 03 was issued dated 05 December 2024 for some clarification/revision/amendments in the bidding documents of the project. A copy of Bid Bulletin No.03 is hereto attached as *Annex "G"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 16 December 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "H" & "I", respectively*;

WHEREAS, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 17 December 2024 and was presented to the BAC on the same date, where it is indicated that the tendered bid proposal of Omniprime Marketing Inc. in Joint Venture with iOM Philippines Inc. to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "J" & "K", respectively*;

WHEREAS, the Committee issued a letter to Omniprime Marketing Inc. in Joint Venture with iOM Philippines Inc., dated 17 December 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as *Annex "L"*;

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 23 December 2024 and was presented to the BAC on the same day, wherein the BAC-TWG (Bravo) recommended that the bid proposal of **Omniprime Marketing Inc. in Joint Venture with iOM Philippines Inc.** be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of **Three Hundred Forty-Nine Million Eight Hundred Eighty-Eight Thousand Eight Hundred Eighty-Eight Pesos & 88/100 (PHP349,888,888.88)**. The recommendation was adopted by the committee. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "M" & "N", respectively*;

WHEREAS, the BAC TWG-Bravo recommended for the award of the project **Omniprime Marketing Inc. in Joint Venture with iOM Philippines Inc.**, in the amount of **Three Hundred Forty-Nine Million Eight Hundred Eighty-Eight Thousand Eight Hundred Eighty-Eight Pesos & 88/100 (PHP349,888,888.88)**.

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.*;

NOW THEREFORE, premises considered, the **CAAP-BAC (Bravo)**, acting upon the recommendation of BAC-TWG (Bravo), hereby **RESOLVES** to **APPROVE** and **AWARD** of the project, Configuration and Implementation of a 3-Year Subscription plan for a Cloud Enterprise Resource Planning (ERP) Solution for Human Resource, Finance and Administrative Operations of the Civil Aviation Authority of the Philippines in the amount of **Three Hundred Forty-Nine Million Eight Hundred Eighty-Eight Thousand Eight Hundred Eighty-Eight Pesos & 88/100 (PHP349,888,888.88)** to **Omniprime Marketing Inc. in Joint Venture with iOM Philippines Inc.**
