**SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, DESIGN AND CONSTRUCTION OF PORTABLE SEWERAGE TREATMENT PLANT (STP) AND INTERCONNECTION OF PIPE NETWORK & SEPTIC TANK. (Bid No. 24-083-10)**

**WHEREAS**, the project, Design and Construction of Portable Sewerage Treatment Plant (STP) and Interconnection of Pipe Network & Septic Tank, an ADMS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Twenty-Six Million Six Hundred Sixty-Nine Thousand Four Hundred Seventy-Six Pesos & 09/100 (PHP26,669,476.09). A copy of the Certificate of Budget Allocation (CBA (CO) No. 24-09-1154) dated 12 September 2024 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 03 October 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 16 October 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS**, the Pre-Bid Conference was conducted on 22 October 2024 via in person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

**WHEREAS**, the Bid Bulletin No. 01 dated 30 October 2024 was issued for clarifications in the bidding documents of the project. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "E"*;

**WHEREAS**, the Submission and Opening of Bids for the project was held on 12 November 2024 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. **WHEREAS**, the BAC - TWG (Alpha) issued its Post-Qualification Report dated 20 November 2024 and was presented to the BAC on 26 November 2024, wherein the BAC-TWG (Alpha) recommends that the bid proposal of Krypton International Resources Sales & Services, Inc. be declared as the Single Calculated and Responsive Bid (SCRB) and that the contract be awarded to the bidder for the project: Design and Construction of Portable Sewerage Treatment Plant (STP) and Interconnection of Pipe Network & Septic Tank in the amount of Twenty-Five Million Seven Hundred Sixty-Eight Thousand Seven Hundred Thirty-One Pesos & 31/100 (PHP25,768,731.31). **NOW, THEREFORE**, premises considered, the **CAAP-BAC RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, **Design and Construction of Portable Sewerage Treatment Plant (STP) and Interconnection of Pipe Network & Septic Tank** in the total amount of Twenty-Five Million Seven Hundred Sixty-Eight Thousand Seven Hundred Thirty-One Pesos & 31/100 (**PHP25,768,731.31**) to **Krypton International Resources Sales & Services, Inc.**
