OASIS RECYCLING & RECOVERY MANAGEMENT CORP. a corporation organized and existing by virtue of law and with office address at Unit 120 Cityland Pioneer Heights 1, Pioneer St., Brgy. Pineda, Pasig City hereinafter called "the Supplier" and represented herein by **JEICHELLE P. DE CLARO** in her capacity as Authorized Representative of the other part.

WHEREAS, CAAP requested quotation for certain good and ancillary services, particularly the *Environmental sanitary services hazardous medical waste (inclusive of permit to transport, PCO accreditation, quarterly monitoring report (SMR) and 12 months medical waste collection)* and has accepted the Quotation by the Supplier for the supply of those goods in the sum of SIXTY-SIX THOUSAND ONE HUNDRED TWENTY PESOS ONLY (Php66,120.00) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively as
- assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (2.1) Annual Procurement Plan CY 2024
 - (2.2) CBA (MOOE) No. 24-05-555 dated 02 May 2024
 - (2.3) Pre-Procurement (CCC) dated 17 May 2024
 - (2.4) Formal Quotation and other attachments from the Supplier
 - (2.5) Abstract of Quotation / CCC Checklist dated 30 October 2024
 - (2.6) Evaluation Report dated 05 November 2024
 - (2.7) CCC Resolution No. 2024-103 dated 06 November 2024
- 3. In consideration of the payments to be made by the Entity to the Supplier as herein mentioned, the Supplier hereby covenants with the Entity to provide the goods and services within **Twelve (12) months** from receipt of the Notice for Compliance and to remedy defects therein in conformity in all respects with the provisions of the Contract.

- 4. The CAAP covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the *Agreement*.
- 5. In case of failure to make the full delivery within the time specified above, a penalty of one-tenth (1/10) of one percent (0.001) for unperformed portion for everyday of delay. Once the cumulative number of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
