



CCC Resolution No. 2024-103

SUBJECT: ENVIRONMENTAL SANITARY SERVICES HAZARDOUS MEDICAL WASTE (INCLUSIVE OF PERMIT TO TRANSPORT, PCO ACCREDITATION, QUARTERLY MONITORING REPORT (SMR) AND 12 MONTHS MEDICAL WASTE COLLECTION).

WHEREAS, Purchase Request/POW/CBA No. 24-05-555 dated 02 May 2024 for the Environmental Sanitary Services Hazardous Medical Waste (Inclusive of Permit to Transport, PCO Accreditation, Quarterly Monitoring Report (SMR) and 12 months Medical Waste Collection) with a total budget of P66,240.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 17 May 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, *"Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR"*. Copy of the minutes hereto attached as **Annex B**;

WHEREAS, the Request for Quotation (RFQ) was twice posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 28 May 2024 and 03 October 2024 respectively, no quotation was received by the CCC Secretariat. The project was posted for the third time on 12 October 2024, only one (1) supplier submitted a quotation but was disqualified due to non compliance on the documentary requirements. The project was reposted again on 23 October 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

WHEREAS, Request for Quotation (RFQ) was sent to the following:

1. OASIS RECYCLING & RECOVERY MANAGEMENT CORP.;
2. DCH ECO GREEN SOLUTIONS;
3. C & G ENVIRONMENTAL MANAGEMENT;
4. ECO CARE TRADING & WASTE MANAGEMENT SERVICES; and
5. GREEN HORIZON ENVIRONMENTAL MANAGEMENT INC.;

WHEREAS, during the opening of the sealed RFQs held on 30 October 2024 at the CAAP, Procurement Division Office, only one (1) supplier submitted a quotation, as follows:

1. OASIS RECYCLING & RECOVERY MANAGEMENT CORP.	P66,120.00

WHEREAS, the end-user evaluation report submitted on 05 November 2024 disclosed that OASIS RECYCLING & RECOVERY MANAGEMENT CORP. complied with all CAAP requirements and specifications and is considered the single calculated and responsive quotation. Copy of the Evaluation hereto attached as **Annex D**;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "*Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation.*"

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC **RESOLVES**, as it is hereby RESOLVED to recommend for **APPROVAL** of the Environmental Sanitary Services Hazardous Medical Waste (Inclusive of Permit to Transport, PCO Accreditation, Quarterly Monitoring Report (SMR) and 12 months Medical Waste Collection) in the total amount of **SIXTY-SIX THOUSAND ONE HUNDRED TWENTY PESOS (P66,120.00)** only, and be **AWARDED** to **OASIS RECYCLING & RECOVERY MANAGEMENT CORP.** the offer of which was considered reasonable and advantageous to the Government;
