## BAC Resolution No. 2024-0910-208 (Bravo)

## SUBJECT: RECOMMENDING THE CANCELLATION OF BIDDING FOR THE PROJECT ENTITLED, EXTENSION OF CONTRACT FOR THE ONE (1) YEAR SOFTWARE SUPPORT SERVICES FOR THALES TOPSKY HE AIR TRAFFIC MANAGEMENT SYSTEM AT PHILIPPINE ATMC

**WHEREAS**, the project, Extension of Contract for the One (1) Year Software Support Services for Thales Topsky HE Air Traffic Management System at Philippine ATMC, an ANS project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of One Hundred Forty-Nine Million Eight Hundred Forty-One Thousand Pesos (PHP149,841,000.00). A copy of the Certificate of Budget Allocation CBA (MOOE) No. 24-10-1288 dated 10 October 2024 is herein attached as *Annex "A"*;

**WHEREAS**, on 04 November 2024 BAC Bravo meeting, the end-user recommended for the cancellation of the project under Section 35.6 of the Revised Implementing Rules and Regulations of Republic Act 9184, which provides that *"xxx, the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, for any justifiable reason, such as but not limited to: (a) the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the end-user unit, xxx". Considering this extension of the ongoing one (1) year contract is aimed as a contingency measure in case the contract between the DOTr and the joint venture of Thales and Sumitomo were not signed within this year for the software support services for the succeeding years until the end of 2027. With the recent signing of the contract between the DOTr and the joint venture of Thales and Sumitomo, the procurement of this project is no longer necessary. A copy of the Minutes of Meeting hereto attached as <i>Annex "B"*;

**NOW, THEREFORE**, premises considered, the CAAP-BAC (BRAVO) **RESOLVES**, as it is hereby **RESOLVED** that the bidding for the project, Extension of Contract for the One (1) Year Software Support Services for Thales Topsky HE Air Traffic Management System at Philippine ATMC be **CANCELLED** and the Bid Documents be reverted to the end user for further action;
