SCOPE OF WORKS/SERVICES

- 1. The payment for the collection of garbage shall be **on a per kilo basis** and shall be paid ever end of the month for the total weight (kg.) of garbage collected for that month. It shall b weighed during garbage collection.
- 2. A collection report for every collection must be prepared and signed both by the servic provider and Procuring Entity and shall be the basis for the payment transaction.



- 3. Regular Waste collection will be twice a week, with additional pickups as needed during pea periods (e.g., holidays, special events) at five o'clock in the morning (5:00 AM) to six o'clock i the evening (6:00 pm), at the BIA Materials Recovery Facility and as requested by th Procuring Entity on a case-to-case basis.
- 4. Collection of solid waste must be handled by trained waste handlers. The Service Provide shall be responsible for the hauling vehicles and other equipment incidental to th performance of this project. Responsible for the on-site segregation of bio-degradable, nor biodegradable and hazardous waste, loading and unloading of all solid wastes collected, wit the consent/presence of BIA authorized personnel.
- 5. Service provider shall provide a garbage collection plan for the whole duration of the contract

Quotations not accompanied by Current Mayor's/Business Permit and Phil-GEPS Registration Number, Bio-data of assigned personnel - at least three (3) trained waste handlers, Proof that the service provider is engaged in the business of garbage collection and disposal for at least three (3) years; List of Contractor's Equipment (Hauling Vehicle with loading capacity of 15 m3; and Weighing Scale) together with proof of ownership, certification of availability of equipment from the equipment lessor/vendor for the duration of the project, as the case may be, which must meet the minimum requirements, and Certification or any proof from the owner of the Sanitary Landfill that the Contractor is allowed to dispose garbage at their premises, shall be automatically disqualified. Your prices must be quoted in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental cost to the delivery site if the contract is awarded.

Quotations will be opened in the presence of the Bidders' representatives who choose to attend at the address below.

Quotations must be delivered to the Civil Aviation Authority of the Philippines, Area Center V at its physical address at the BAC/CCC Office, Ground Floor Admin Bldg., Bicol International Airport, Daraga, Albay not later than 2:00 p.m. on 31 January 2025.

Online submission is not allowed and late quotations shall not be accepted. All quotations together with the required documents should be placed in a sealed envelope marked Garbage Collection and Disposal Services of Solid Waste at Bicol International Airport.
