## **Contract Agreement**

For

RENEWAL OF CONTRACT FOR COURIER SERVICE FOR THE DELIVERY AND HAULING OF EQUIPMENT, PARTS, MATERIALS AND OTHER ACCESSORIES INCLUDING DOCUMENTS OF VARIOUS CNS, MET AND ELECTRO-MECHANICAL FACILITIES

**LIBCAP SUPER EXPRESS CORPORATION,** a corporation organized and existing by virtue of law and with office address at LIBCAP Building, Quintin Salas, Jaro, Iloilo City hereinafter called "the Supplier" and represented herein by **MARIA LUCIA G. MONDRAGON** in her capacity as President of the other part.

WHEREAS, CAAP requested quotation for certain good and ancillary services, particularly the *Renewal of Contract for Courier Service for the Delivery and Hauling of equipment, parts, materials and other accessories including documents of various CNS, MET and Electro-Mechanical Facilities* and has accepted the Quotation by the Supplier for the supply of those goods in the sum of SEVEN HUNDRED FIFTY-TWO THOUSAND THREE HUNDRED THIRTY-SEVEN PESOS & 60/100 ONLY (Php752,337.60) hereinafter called "the Contract Price".

## **NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:**

- 1. In this Agreement words and expressions shall have the same meanings as are respectively as assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
  - (2.1) CBA (MOOE) No. 24-08-1075 dated 22 August 2024
  - (2.2) Contract No. G-2023-146 dated 16 February 2024
  - (2.3) Program of Work
  - (2.4) Minutes of Meeting dated 20 September 2024
  - (2.5) End User's Performance Evaluation of Supplier/Contractor
  - (2.6) BAC Resolution No. 2024-0910-181 (Bravo) dated 23 September 2024
  - (2.7) Notice of Renewal dated 12 November 2024
  - (2.8) Performance Bond

3. In consideration of the payments to be made by the Entity to the Supplier as herein mentioned, the Supplier hereby covenants with the Entity to provide the goods and services within **One (1) Year** from receipt of this contract and to remedy defects therein in conformity in all respects with the provisions of the Contract.

- 4. The CAAP covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the *Agreement*.
- 5. In case of failure to make the full delivery within the time specified above, a penalty of one-tenth (1/10) of one percent (0.001) for unperformed portion for everyday of delay. Once the cumulative number of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
