RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, INTERNATIONAL **AIRPORT DEVELOPMENT** PROJECT (REHABILITATION/IMPROVEMENT OF PASSENGER **TERMINAL BUILDING - SUPPLY, INSTALLATION, AND COMMISSIONING OF THREE** (3) UNITS 600 KW CHILLER) (Bid No. 24-063-09 - Alpha)

WHEREAS, project, International lloilo Airport Development (Rehabilitation/Improvement of Passenger Terminal Building - Supply, Installation, and Commissioning of Three (3) Units 600 Kw Chiller), an ADMS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Forty-Four Million Six Ninety-Three Thousand Six Hundred Forty-One Pesos & 60/100 (PHP44,693,641.60). WHEREAS, the Bids and Awards Committee - Technical Working Group Alpha (BAC-TWG Alpha) issued its Bid Evaluation Report dated 17 October 2024 and was presented to the BAC on the same day. It was recommended that Warlen Industrial Sales Corp. and LDC Refrigeration & Airconditioning, Inc. be disqualified for offering an "INCOMPLETE" bids during the bid evaluation due to non-conformity with the Bill of Quantities and its components of the BDS, and that True Temp Corporation be declared to undergo the Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB) in the amount of Thirty-Seven Million Five Hundred Fifty-One Thousand One Hundred Twenty-Four Pesos & 98/100 (PHP37,551,124.98). The copies of the said Report and Minutes of Meeting are hereto attached as Annexes "I" & "J", respectively;

WHEREAS, the Committee issued a letter to True Temp Corporation dated 17 October 2024, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as Annex "K";

WHEREAS, the BAC-TWG (Alpha) issued its Post-Qualification Report dated 28 October 2024 and was presented to the BAC on 31 October 2024, wherein the BAC-TWG (Alpha) recommends that the contract be awarded to True Temp Corporation for being the Single Calculated Responsive Bid (SCRB) for the project: Iloilo International Airport Development Project (Rehabilitation/Improvement of Passenger Terminal Building - Supply, Installation, and Commissioning of Three (3) Units 600 Kw Chiller) in the amount of Thirty-Seven Million Five Hundred Fifty-One Thousand One Hundred Twenty-Four Pesos & 98/100 (PHP37,551,124.98). The copies of the said Report and Minutes of Meeting are hereto attached as Annexes "L" & "M", respectively;

WHEREAS, the Committee issued a Notice of Disqualifications to Warlen Industrial Sales Corp. and LDC Refrigeration and Airconditioning, Inc., dated 04 November 2024. The copies of the Notice of Disqualifications are hereto attached as Annex "N";

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed;

NOW, THEREFORE, premises considered, the CAAP-BAC RESOLVES, as it is hereby RESOLVED to recommend the APPROVAL and AWARD of the project, ILOILO **PROIECT** INTERNATIONAL **AIRPORT** DEVELOPMENT (REHABILITATION/IMPROVEMENT OF PASSENGER TERMINAL BUILDING - SUPPLY. INSTALLATION, AND COMMISSIONING OF THREE (3) UNITS 600 KW CHILLER) in the total amount of Thirty-Seven Million Five Hundred Fifty-One Thousand One Hundred Twenty-Four Pesos & 98/100 (PHP37,551,124.98) to True Temp Corporation.
