Pursuant to the powers vested on the Director General of the Civil Aviation Authority of the Philippines under Republic Act No. 9497, otherwise known as the Civil Aviation Authority Act of 2008 and in accordance with the Regulations Amendment/Revision Procedure with Board Resolution No. 2012-054 dated 28 September 2012, I hereby approve the amendments to the Philippine Civil Aviation Regulations Part 4:

4.3.1.13 CERTIFICATE OF DEREGISTRATION


- (a) The certificate of deregistration is will be issued in English language.
- (b) The certificate of deregistration shall include: The certificate of deregistration will be issued in a form as prescribed in IS 4.3.1.13.
 - (1) ~~Registered Owner;~~
 - (2) ~~Registered Operator;~~
 - (3) ~~Nationality and Registration Mark;~~
 - (4) ~~Manufacturer;~~

IS 4.3.1.13 CERTIFICATE OF DEREGISTRATION

The certificate of deregistration will be issued using Figure 1 and contain the following details:

- (a) Nationality and Registration Marks;
- (b) Manufacturer and manufacturer's designation of aircraft;
- (c) Aircraft Serial Number;
- (d) Name of certificate holder;
- (e) Address of certificate holder;
- (f) Name and contact information of owner, if different from certificate holder;
- (g) Deregistration statement with name of register and date;
- (h) Reason(s) for deregistration, if known; and
- (i) Signature of Director General.

Separability Clause. If, for any reason, any provision of this Memorandum Circular is declared invalid or unconstitutional, the other part or parts thereof which are not affected thereby shall continue to be in full force and effect.


Text deleted: Text to be deleted is shown with a line through it.

Effectivity. This Memorandum Circular shall take effect ~~fifteen~~ ⁽¹⁵⁾ days after compliance with the requisite publication in a single newspaper of general circulation and a copy filed with the U.P. Law Center – Office of the National Administrative Register, these amendments shall be incorporated into the Philippine CAR, series of 2024.
