BAC Resolution No 2024-0910-219 (Bravo)

SUBJECT:

RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, PERIODIC MAINTENANCE SERVICE FOR OSHKOSH FIRE TRUCKS

**WHEREAS**, the project Periodic Maintenance Service for Oshkosh Fire Trucks, an ADMS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to **Nine Million Nine Hundred Five Thousand Seventy Pesos (Php 9,905,070.00)**. A copy of the Certificate of Budget Allocation (CBA (MOOE) No. 24-05-575 dated 06 May 2024) is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement was on 19 August 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

**WHEREAS**, the Invitation to Bid (ITB) was posted on 20 September 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS,** Pre-bid Conference was conducted on 30 September 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

**WHEREAS,** The Committee issued a Bid Bulletin No. 01 dated 09 October 2024, which contained the new schedule for Submission and Opening of Bids. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "E"*;

**WHEREAS**, the Committee issued a Bid Bulletin No. 02 dated 16 October 2024, which answers queries made by prospective bidders about the project. A copy of the Bid Bulletin No. 02 is hereto attached as *Annex "F"*;

**WHEREAS**, The Committee issued a Bid Bulletin No. 03 dated 18 October 2024, which contained the new schedule for Submission and Opening of Bids. A copy of the Bid Bulletin No. 03 is hereto attached as *Annex "G"*;

**WHEREAS**, on 30 October 2024, during the Submission and Opening of Bids at the BAC Bravo meeting, the BAC members and TWG declared a bidding failure under Section 35.1 (a) of the Revised Implementing Rules and Regulations of Republic Act 9184, considering that no bidders submitted their bid. A copy of the Minutes of Meeting is hereto attached as *Annex "H"*;

**WHEREAS**, Section 35.1 (a) of the Revised Implementing Rules and Regulations of RA 9184 provides that: *"The BAC shall declare the bidding a failure when no bids are received"*;
