



BAC Resolution No. 2024-0910-286 (Bravo)

SUBJECT:

PROJECT RECOMMENDING THE AWARD FOR THE PREVENTIVE MAINTENANCE AND TESTING OF 1.5 MVA SUBSTATION

AND SWITCHGEARS OF THE PHILIPPINE ATM CENTER

WHEREAS, the project Preventive Maintenance and Testing of 1.5 MVA Substation and Switchgears of Philippine ATM Center, an ANS project, was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to One Million Nine Hundred Seventy-One Thousand Nine Hundred Sixty-One Pesos and 80/100 (PHP1,971,961.80). A copy of the Certificate of Budget Allocation CBA (MOOE) NO.: 24-08-1091 dated 30 August 2024 is herein attached as Annex "A";

WHEREAS, the Pre-Procurement Conference was conducted on 04 October 2024 via inperson meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as Annex "B";

WHEREAS the Invitation to Bid (ITB) was posted on 31 October 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as Annex "C";

WHEREAS, the Pre-bid Conference was conducted on 11 November 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as Annex "D":

WHEREAS, the Submission and Opening of Bids for the project was held on 25 November 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as Annexes "E" & "F", respectively;

WHEREAS, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 27 November 2024 and was presented to the BAC on the same date, where it is indicated that the tendered bid proposal of Exquis Electrical Services and Supplies Co. to undergo Post-Qualification process for being evaluated and considered as the Lowest Calculated Bid (LCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of said Report and Minutes of Meeting are hereto attached as Annexes "G" & "H", respectively;

WHEREAS, the Committee issued a letter to Exquis Electrical Services and Supplies Co., dated 28 November 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as Annex "I";

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 23 December 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC-TWG (Bravo) recommended that the bid proposal of Exquis Electrical Services and Supplies Co. be declared as Lowest Calculated Responsive Bid (LCRB) and that the contract be awarded to the bidder in the amount of One Million Ninety-Seven Thousand Six Hundred Pesos (PHP1,097,600.00). The copy of said Report and Minutes of Meeting are hereto attached as Annexes "J" & "K", respectively.;

WHEREAS, the BAC TWG-Bravo recommended for the award of the project Exquis Electrical Services and Supplies Co., in the amount of One Million Ninety-Seven Thousand Six Hundred Pesos (PHP1,097,600.00).

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;

NOW THEREFORE, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of BAC-TWG (Bravo), hereby RESOLVES to APPROVE and AWARD of the project, Preventive Maintenance and Testing of 1.5 MVA Substation and Switchgears of Philippine ATM Center in the amount of One Million Ninety-Seven Thousand Six Hundred Pesos (PHP1,097,600.00) to Exquis Electrical Services and Supplies Co.
