BAC Resolution No. 2024-0910-251 (Bravo)

SUBJECT: RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, PROCUREMENT OF DISASTER RECOVERY SYSTEM (DRS) FOR THALES TOPSKY-HE AIR TRAFFIC MANAGEMENT SYSTEM (ATMS) FOR THE PHILIPPINE AIR TRAFFIC MANAGEMENT CENTER (ATMC)

WHEREAS, the project Procurement of Disaster Recovery System (DRS) for Thales Topsky-HE Air Traffic Management Center (ATMC), an ANS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to **One Hundred Ninety-Eight Million Pesos** (**PHP198,000,000.00**). A copy of the Certificate of Budget Allocation (CBA (C.O) No. 24-10-1286 dated 07 October 2024) is herein attached as *Annex "A"*;

WHEREAS, the Confirmation/Determination of Mode was conducted on 30 October 2024, wherein the end-user requested for the confirmation of mode of procurement be done through Direct Contracting substantiated by the Certificate of Sole and Exclusive Proprietorship made by Airspace Mobility Solutions. The change of mode was approved by the Committee. The copies of the Minutes of Meeting and the Certificate of Sole and Exclusive Distributorship are hereto attached as *Annexes "B" & "C" respectively;*

WHEREAS, the Notice of Direct Contracting and Request for Quotation was posted on 22 November 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Notice of Direct Contracting is hereto attached as *Annex "D*";

WHEREAS, Bid Bulletin No. 01 was issued dated 21 November 2024 indicating the new schedule for the Submission and Opening of Bids. A copy of the said Bid Bulletin No. 1 is hereto attached as *Annex "E"*;

WHEREAS, on 06 December, 2024, during the Submission and Opening of Bids at the BAC Bravo meeting, the BAC members and TWG declared a bidding failure under Section 35.1 (a) of the Revised Implementing Rules and Regulations of Republic Act 9184, considering that no bidders submitted their bid. A copy of the Minutes of Meeting is hereto attached as *Annex "F"*;

WHEREAS, Section 35.1 (a) of the Revised Implementing Rules and Regulations of RA 9184 provides that: *"The BAC shall declare the bidding a failure when no bids are received"*;

NOW THEREFORE, the CAAP-BAC BRAVO acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby **RESOLVED** to recommend that the project, **Procurement of Disaster Recovery System (DRS) for Thales Topsky-He Air Traffic**
