



BAC Resolution No. 2024-0910-271 (Bravo)

SUBJECT: RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, PROCUREMENT OF NEW AERONAUTICAL INFORMATION SERVICE (AIS) SYSTEM

WHEREAS, the project Procurement of New Aeronautical Information Service (AIS) System, an ANS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to **Three Hundred Million Pesos (PHP300,000,000.00)**. A copy of the Certificate of Budget Allocation (CBA (CO) No. 24-09-1133 dated 09 September 2024) is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement was on 09 October 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) was posted on 06 November 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, Pre-bid Conference was conducted on 13 November 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, Bid Bulletin No.01 was issued dated 21 November 2024, for some clarifications/revisions/amendments in the bidding documents for the project. A copy of Bid Bulletin No.01 is hereto attached as *Annex "E"*;

WHEREAS, Bid Bulletin No.02 was issued dated 21 November 2024, re-scheduling the Submission and Opening of Bids for the project. A copy of Bid Bulletin No.01 is hereto attached as *Annex "F"*;

WHEREAS, the Submission and Opening of bids for the project was held on 04 December 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "G" & "H", respectively*;

ADL Coordinated Pvt. Ltd	-disqualified (failure to attach PhilGEPS Certificate of Registration)



WHEREAS, a Request for Reconsideration was received by the Committee dated 06 December 2024 from ADL Coordinated Pvt. Ltd. A copy of the Request for Reconsideration is hereto attached as *Annex "I"*;

WHEREAS, The BAC members and TWG declare failure of bidding for the project dated 09 December 2024 under Section 35.1 (c) of the Revised Implementing Rules and Regulations of Republic Act 9184, considering that the lone bidder is disqualified for failure to comply with all the bid requirements. A copy of the Minutes of the Meeting is hereto attached as *Annex "J"*;

WHEREAS, Section 35.1 (c) of the Revised Implementing Rules and Regulations of RA 9184 provides that: *"The BAC shall declare the bidding a failure when: c) all bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation"*;

WHEREAS, the Committee issued its reply to the Request for Reconsideration of ADL Coordinated Pvt. Ltd. denying their request dated 11 December 2024. A copy of the reply to the Request for Reconsideration is hereto attached as *Annex "K"*;

NOW THEREFORE, the CAAP-BAC BRAVO acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby **RESOLVED** to recommend that the project, **PROCUREMENT OF NEW AERONAUTICAL INFORMATION SERVICE (AIS) SYSTEM** be declared a **FAILURE** and to return the bid documents to the end-user for mandatory review;


