WHEREAS, the project, Disaster Preparedness Awareness Month Campaign: Provision of Emergency Go Bags for the use of CAAP Employees as part of the Disaster Resilience and Emergency Preparedness Campaign during the Celebration of the National Disaster Resilience Month, an ODG-BCMG project, was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting

WHEREAS, the Bids and Awards Committee-Technical Working Group (BAC-TWG Bravo) issued its Bid Evaluation Report dated 05 November 2024 and was presented to the BAC on 06 November 2024, where it is indicated that the calculated bid proposal of Star Care Medical Supplies. is hereby recommended to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB). WHEREAS, the Committee issued a letter to Star Care Medical Supplies. dated 06 November 2024, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "M"*;

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 20 November 2024 and was presented to the BAC on 25 November 2024, wherein the BAC TWG (Bravo) recommended that the bid proposal of Star Care Medical Supplies. be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of One Million Two Hundred Fifty-Eight Thousand Pesos (Php 1,258,000.00). WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend* to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;

NOW, THEREFORE, premises considered, the CAAP-BAC (BRAVO) RESOLVES, as it is hereby RESOLVED to recommend the APPROVAL and AWARD of the project, Disaster Preparedness Awareness Month Campaign: Provision of Emergency Go Bags for the use of CAAP Employees as part of the Disaster Resilience and Emergency Preparedness Campaign during the Celebration of the National Disaster Resilience Month in the total amount of One Million Two Hundred Fifty-Eight Thousand Pesos (Php 1,258,000.00) to Star Care Medical Supplies.
