

BAC Resolution No. 2024-0910-283 (Bravo)

SUBJECT:

RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, PURCHASE AND INSTALLATION OF COMMUNICATIONS EQUIPMENT FOR BICOL (NEW LEGASPI) INTERNATIONAL AIRPORT

WHEREAS, the project Purchase and Installation of Communications Equipment for Bicol (New Legaspi) International Airport, an ANS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to **Forty-Seven Million One Hundred Forty-Six Thousand Six Pesos & 26/100** (**PHP47,146,006.26**). A copy of the Certificate of Allotment Release (CAR No. 2024-01-003 dated 16 January 2024) is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 30 October 2024 via inperson meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 07 November 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

WHEREAS, the Pre-bid Conference was conducted on 15 November 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*:

WHEREAS, Bid Bulletin No. 01 dated 26 November 2024 was issued for the new schedule of the Submission and Opening of Bids of the Project. A copy of Bid Bulletin No. 01 is hereto attached as *Annex "E"*;

WHEREAS, **Bid** Bulletin No. 02 dated 29 November 2024 was issued for some clarification/revision/amendments in the bidding documents of the project. A copy of Bid Bulletin No. 02 is hereto attached as *Annex "F"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 06 December 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted its bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "G"* & "H", respectively;

WHEREAS, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 09 December 2024 and was presented to the BAC on the same date, where it is indicated that the tendered bid proposal of Evercon Builders and Equipment Corporation. to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. WHEREAS, the Committee issued a letter to Evercon Builders and Equipment Corporation., dated 09 December 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as *Annex "K"*;

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 23 December 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC-TWG (Bravo) recommended that the bid proposal of Evercon Builders and Equipment Corporation. be declared as Single Calculated Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of Forty-Six Million Nine Hundred Eighty-Eight Thousand Eight Hundred Eighty-Eight Pesos & 42/100 (PHP46,988,888.42). The copy of said Report and Minutes of Meeting are hereto attached as Annexes "L" & "M", respectively.;

WHEREAS, the BAC TWG-Bravo recommended for the award of the project Evercon Builders and Equipment Corporation., in the amount of Forty-Six Million Nine Hundred Eighty-Eight Thousand Eight Hundred Eighty-Eight Pesos & 42/100 (PHP46,988,888.42).

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend* to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;

NOW THEREFORE, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of BAC-TWG (Bravo), hereby RESOLVES to APPROVE and AWARD of the project, Purchase of Purchase and Installation of Communications Equipment for Bicol (New Legaspi) International Airport in the amount of Forty-Six Million Nine Hundred Eighty-Eight Thousand Eight Hundred Eighty-Eight Pesos & 42/100 (PHP46,988,888.42) to Evercon Builders and Equipment Corporation.
