WHEREAS, CAAP requested quotation for certain good and ancillary services, particularly the *Purchase of ADMS various Photocopying Machine Toners* and has accepted the Quotation by the Supplier for the supply of those goods in the sum of TWO HUNDRED SEVENTY-SEVEN THOUSAND FIVE HUNDRED SIXTY PESOS ONLY (Php277,560.00) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:

In consideration of the payments to be made by the Entity to the Supplier as herein mentioned, the Supplier hereby covenants with the Entity to provide the goods and services within **Thirty (30) calendar days** from receipt of this contract and to remedy defects therein in conformity in all respects with the provisions of the Contract.

- 4. The CAAP covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the *Agreement*.
- 5. In case of failure to make the full delivery within the time specified above, a penalty of one-tenth (1/10) of one percent (0.001) for unperformed portion for everyday of delay. Once the cumulative number of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
