



BAC Resolution No. 2024-0910-268 (Bravo)

SUBJECT:

RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, PURCHASE OF GNSS EQUIPMENT, SOFTWARE AND ITS ACCESSORIES

**WHEREAS**, the project Purchase of GNSS Equipment, Software, and its Accessories, an ADMS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to Fifteen Million Pesos (**PHP15,000,000.00**). A copy of the Certificate of Budget Allocation (CBA (C.O) No. 24-01-013 dated 09 January 2024) is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 23 September 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 18 October 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

**WHEREAS,** a Notice of Postponement was issued dated 25 October 2024, suspending all BAC proceedings due to inclement weather. A copy of the Notice of Postponement is hereto attached as *Annex "D"*;

**WHEREAS**, the Pre-bid Conference was conducted on 28 October 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "E"*;

**WHEREAS,** Bid Bulletin No. 01 was issued dated 05 November 2024 for some clarification/revision/amendments in the bidding documents of the project. A copy of Bid Bulletin No.01 is hereto attached as *Annex "F"*;

**WHEREAS**, the Submission and Opening of Bids for the project was held on 13 November 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "G"* & "H", respectively;

WHEREAS, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 15 November 2024 and was presented to the BAC on the same date, where it is indicated that the tendered bid proposal of MJAS Zenith Trading. to undergo Post-Qualification process for being evaluated and considered as the Lowest Calculated Bid (SCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of said Report and Minutes of Meeting are hereto attached as Annexes "I" & "J", respectively;

WHEREAS, the Committee issued a letter to MJAS Zenith Trading., dated 15 November 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as Annex "K";

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 29 November 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC-TWG (Bravo) recommended that the bid proposal of MJAS Zenith Trading. be Post-Disqualified for their failure to comply with the technical specification, particularly regarding the battery and GNSS Technology, as it does not include anti-spoofing capabilities. The GNSS Base requires a battery capacity of 14 hours, along with at least two spare batteries per unit. However, the offered battery consists of 4 pieces per unit, each with a 6.25hour capacity based on the brochure, which does not meet the specified requirements and for Argotek Incorporated to undergo Post-Qualification for being evaluated as the Second Lowest Calculated Bid (sLCB) in the amount of Fourteen Million Four Hundred Fifty Thousand Pesos (PHP14,450,000.00). WHEREAS, the Committee issued a letter to Argotek Incorporated., dated 29 November 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as Annex "N";

WHEREAS, the Committee issued a Notice of Post-Disqualification to MJAS Zenith Trading dated 02 December 2024. A copy of the Notice of Post-Disqualification is hereto attached as Annex "O";

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 11 December 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC-TWG (Bravo) recommended that the bid proposal of Argotek Incorporated. be declared as Lowest Calculated Responsive Bid (LCRB) and that the contract be awarded to the bidder in the amount of Fourteen Million Four Hundred Fifty Thousand Pesos (PHP14,450,000.00). The copy of said Report and Minutes of Meeting are hereto attached as Annexes "P" & "Q", respectively.;

WHEREAS, the BAC TWG-Bravo recommended for the award of the project Argotek Incorporated., in the amount of Fourteen Million Four Hundred Fifty Thousand Pesos (PHP14,450,000.00).





WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;

NOW THEREFORE, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of BAC-TWG (Bravo), hereby RESOLVES to APPROVE and AWARD of the project, Purchase of GNSS Equipment, Software, and its Accessories in the amount of Fourteen Million Four Hundred Fifty Thousand Pesos (PHP14,450,000.00) to Argotek Incorporated.
