



BAC Resolution No. 2024-0910-279 (Bravo)

SUBJECT: RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, PURCHASE/INSTALLATION OF ILS FOR ILOILO INTERNATIONAL AIRPORT. (Bid No. 24-058-08 Bravo)

WHEREAS, the project, Purchase/Installation of ILS for Iloilo International Airport, an ANS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget of Fifty-Seven Million Two Hundred Forty-Eight Thousand Twenty-One Pesos & 85/100 (PHP57,248,021.85). A copy of the Certificate of Budget Allocation CBA (CO) 24-05-550 dated 02 May 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement was on 19 July 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) was posted on 14 August 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, The Committee issued a Bid Bulletin No. 01 dated 16 August 2024, which contained the new schedules of Pre-Bid Conference and Submission and Opening of Bids. A copy of the Bid Bulletin No. 1 is hereto attached as *Annex "D"*;

WHEREAS, Pre-Bid Conference was conducted on 29 August 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "E"*;

WHEREAS, the Committee issued a Bid Bulletins No. 02 and 03 dated 06 September 2024, which comprised amendments and revisions in the bidding documents, along with the new schedule of the Submission and Opening of Bids for this project. The copies of the Bid Bulletins No. 02 and 03 are hereto attached as *Annex "F"*;

WHEREAS, the Committee received a Clarification Letter from Indra Philippines, Inc. dated 09 September 2024. A copy of the letter is hereto attached as *Annex "G"*;

WHEREAS, the Committee issued a reply to the Clarification Letter of Indra Philippines, Inc. dated 16 September 2024. A copy of the reply letter is hereto attached as *Annex "H"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 18 September 2024 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "I" & "J"*, respectively;

WHEREAS, the Bids and Awards Committee - Technical Working Group (BAC-TWG Bravo) issued its Bid Evaluation Report dated 23 September 2024 and was presented to the BAC on the same day, wherein it was recommended that the bid proposal of PHILCOX (Philippines), Inc. be declared as the Single Calculated Bid (SCB) and subject its bid proposal for post-qualification for the project: Purchase/Installation of ILS for Iloilo International Airport. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "K" & "L", respectively*;

WHEREAS, the Committee issued a letter to PHILCOX (Philippines), Inc. dated 23 September 2024, requiring the same to submit the necessary additional requirements for post-qualification. A copy of the said letter is hereto attached as *Annex "M"*;

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 21 October 2024 and was presented to the BAC on the same day, wherein the BAC-TWG (Bravo) recommended that the bid proposal of PHILCOX (Philippines), Inc. be post-disqualified for failure to disclose its ongoing contracts with SBMA Airport; non-conformity with the technical specifications; failure to provide ISO 14001 Certificate or its equivalent; and failure to submit the Cash Flow by quarter. The BAC-TWG Bravo also recommends the failure of bidding for this project. The recommendation was adopted by the committee. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "N" & "O", respectively*;

WHEREAS, a Notice of Post-Disqualification was sent to PHILCOX (Philippines), Inc. dated 21 October 2024. A copy of the Notice of Disqualification is hereto attached as *Annex "P"*;

WHEREAS, the Committee received a Request for Reconsideration from PHILCOX (Philippines), Inc. dated 04 November 2024. A copy of the Request for Reconsideration letter is hereto attached as *Annex "Q"*;

WHEREAS, the Committee issued a reply to the Request for Reconsideration of PHILCOX (Philippines), Inc. on 07 November 2024, indicating that the request was denied. A copy of reply to the Request for Reconsideration is hereto attached as *Annex "R"*;


WHEREAS, Section 35.1 (c) of the Revised Implementing Rules and Regulations of RA 9184 provides that: *"The BAC shall declare the bidding a failure when all bids fail to comply with all the bid requirements or fail post-qualification, or in the case of Consulting Services, there is no successful negotiation"*;


