



BAC Resolution No. 2024-0910-262 (Bravo)

SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, PURCHASE/INSTALLATION OF METEOROLOGICAL INSTRUMENTS FOR VARIOUS AIRPORTS (SINGLE SITE)

WHEREAS, the project, Purchase/Installation of Meteorological Instruments for Various Airports (Single Site), an ANS project was forwarded to the Bids and Awards Committee - Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of **Forty-Two Million Nine Hundred Fifteen Thousand Four Hundred Ninety Pesos & 7/100 (PHP42,915,490.07)**. A copy of the Certificate of Budget Allocation CBA (MOOE) 24-04-516 (FY-2025) dated 23 April 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 23 September 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) was posted on 16 October 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, the Committee issued a Notice of Postponement on 23 October 2024, stating that all agenda items, including the Pre-Bid Conference of this project, would be moved to 25th. A copy of the Notice of Postponement is hereto attached as *Annex "D"*;

WHEREAS, a Notice of Postponement was issued dated 25 October 2024, stating that all agenda items, including the Pre-Bid Conference of this project, would be moved again to 28th. A copy of the Notice of Postponement is hereto attached as *Annex "E"*;

WHEREAS, the Pre-Bid Conference was conducted on 28 October 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "F"*;

WHEREAS, the Committee issued a Bid Bulletin No. 01 dated 30 October 2024, which comprised amendments and revisions in the bidding documents, along with the new schedule of the Submission and Opening of Bids. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "G"*;

WHEREAS, the Bid Bulletin No. 02 dated 30 October 2024, was issued for clarifications in the bidding documents of the project. A copy of the Bid Bulletin No. 02 is hereto attached as *Annex "H"*;

WHEREAS, the Committee issued a Bid Bulletin No. 03 dated 06 November 2024, which contained clarifications in the bidding documents for this project. A copy of the Bid Bulletin No. 03 is hereto attached as *Annex "I"*;



WHEREAS, the Submission and Opening of Bids for the project was held on 20 November 2024 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "J" & "K", respectively*;

WHEREAS, the Bids and Awards Committee - Technical Working Group (BAC-TWG Bravo) issued its Bid Evaluation Report dated 22 November 2024 and was presented to the BAC on 25 November 2024, wherein it was recommended that the bid proposal of Domestic Trading Corporation be declared as the Single Calculated Bid (SCB) in the amount of Forty-Two Million Four Hundred Four Thousand Three Hundred Thirty-Five Pesos & 60/100 (PHP42,404,335.60) and subject its bid proposal for post-qualification for the project: Purchase/Installation of Meteorological Instrument for Various Airports (Single Site). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "L" & "M", respectively*;

WHEREAS, the Committee issued a letter to Domestic Trading Corporation dated 25 November 2024, requiring the same to submit the necessary additional requirements for post-qualification. A copy of the said letter is hereto attached as *Annex "N"*;

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 04 December 2024 and was presented to the BAC on 06 December 2024, wherein the BAC-TWG (Bravo) recommended that the bid proposal of **Domestic Trading Corporation** be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of **Forty-Two Million Four Hundred Four Thousand Three Hundred Thirty-Five Pesos & 60/100 (PHP42,404,335.60)**. The recommendation was adopted by the committee. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "O" & "P", respectively*;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.*;

NOW, THEREFORE, premises considered, the **CAAP-BAC (BRAVO) RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, **PURCHASE/INSTALLATION OF METEOROLOGICAL INSTRUMENTS FOR VARIOUS AIRPORTS (SINGLE SITE)** in the total amount of **Forty-Two Million Four Hundred Four Thousand Three Hundred Thirty-Five Pesos & 60/100 (PHP42,404,335.60)** to **Domestic Trading Corporation**.


