



BAC Resolution No. 2024-0910-238 (Alpha)

SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, PURCHASE/INSTALLATION OF PAPI SYSTEM AT SAN JOSE AIRPORT (Bid No. 24-096-10 Alpha)

WHEREAS, the project, Purchase/Installation of PAPI System at San Jose Airport, an ANS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Twenty-Five Million Six Hundred Seven Thousand Nine Hundred Thirty-Four Pesos & 76/100 (PHP25,607,934.76). A copy of the Certificate of Budget Allocation (CBA (CO) No. 24-09-1171) dated 16 September 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 08 October 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) was posted on 30 October 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, the Pre-Bid Conference was conducted on 07 November 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, the Committee issued a Bid Bulletin No. 01 dated 12 November 2024, which comprised the amendments/revisions to the bidding documents along with the clarifications for this project. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "E"*;

WHEREAS, the Bid Bulletin No. 02 dated 14 November 2024, was issued for the new schedule of the Submission and Opening of Bids. A copy of the Bid Bulletin No. 02 is hereto attached as *Annex "F"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 21 November 2024 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "G" & "H"*, respectively;

WHEREAS, the Bids and Awards Committee - Technical Working Group (BAC-TWG Alpha) issued its Bid Evaluation Report dated 28 November 2024 and was presented to the BAC on the same day, where it is indicated that the calculated bid proposal of Evercon Builders and Equipment Corporation is hereby recommended to be declared as the Single Calculated Bid (SCB) and that Post Qualification evaluation be conducted to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "I" & "J", respectively;*

WHEREAS, the Committee issued a letter to Evercon Builders and Equipment Corporation dated 28 November 2024, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "K";*

WHEREAS, the BAC - TWG (Alpha) issued its Post-Qualification Report dated 03 December 2024 and was presented to the BAC on the same day, wherein the BAC-TWG (Alpha) recommends that the bid proposal of Evercon Builders and Equipment Corporation be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder for the project: Purchase/Installation of PAPI System at San Jose Airport in the amount of Twenty-Five Million Two Hundred Eighty-Eight Thousand Eight Hundred Ninety Four Pesos & 80/100 (PHP25,288,894.80). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "L" & "M", respectively;*

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed;*

NOW, THEREFORE, premises considered, the **CAAP-BAC RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, **Purchase/Installation of PAPI System at San Jose Airport** in the total amount of Twenty-Five Million Two Hundred Eighty-Eight Thousand Eight Hundred Ninety Four Pesos & 80/100 (**PHP25,288,894.80**) to **Evercon Builders and Equipment Corporation**.
