



BAC Resolution No. 2024-0910-239 (Alpha)

SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, PURCHASE/INSTALLATION OF PAPI SYSTEM AT SAN VICENTE AIRPORT (Bid No. 24-095-10 Alpha)

WHEREAS, the project, Purchase/Installation of PAPI System at San Vicente Airport, an ANS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Twenty-Six Million Eighty-Three Thousand Five Hundred Ninety-Five Pesos & 22/100 (PHP26,083,595.22). A copy of the Certificate of Budget Allocation (CBA (CO) No. 24-09-1172) dated 16 September 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 08 October 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) was posted on 30 October 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, the Pre-Bid Conference was conducted on 07 November 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, the Committee issued a Bid Bulletin No. 01 dated 12 November 2024, which comprised the amendments/revisions to the bidding documents along with the clarifications for this project. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "E"*;

WHEREAS, the Bid Bulletin No. 02 dated 14 November 2024, was issued for the new schedule of the Submission and Opening of Bids. A copy of the Bid Bulletin No. 02 is hereto attached as *Annex "F"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 21 November 2024 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. WHEREAS, the BAC - TWG (Alpha) issued its Post-Qualification Report dated 03 December 2024 and was presented to the BAC on the same day, wherein the BAC-TWG (Alpha) recommends that the bid proposal of Evercon Builders and Equipment Corporation be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder for the project: Purchase/Installation of PAPI System at San Vicente Airport in the amount of Twenty-Five Million Seven Hundred Thirty Eight Thousand Eight Hundred Eighty-Five Pesos & 55/100 (PHP25,738,885.55). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "L" & "M", respectively*;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed*;

NOW, THEREFORE, premises considered, the **CAAP-BAC RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, **Purchase/Installation of PAPI System at San Vicente Airport** in the total amount of Twenty-Five Million Seven Hundred Thirty Eight Thousand Eight Hundred Eighty-Five Pesos & 55/100 (**PHP25,738,885.55**) to **Evercon Builders and Equipment Corporation**.
