



BAC Resolution No. 2024-0910-270 (Bravo)

SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF 300 MBPS DEDICATED LEASED-LINE INTERNET SERVICE FOR CAAP HEAD OFFICE

WHEREAS, the project Supply, Delivery, Installation and Commissioning of 300 MBPS Dedicated Leased-Line Internet Service for CAAP Head Office, an ODG-Corplan/MISD project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to **One Million Six Hundred Thousand Pesos (PHP1,600,000.00)**. A copy of the Certificate of Budget Allocation (CBA (MOOE) No. 24-07-963 dated 30 July 2024) is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 11 September 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 18 September 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

WHEREAS, the Pre-bid Conference was conducted on 25 September 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 07 October 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "E" & "F", respectively*;

WHEREAS, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 21 October 2024 and was presented to the BAC on the same date, where it is indicated that the tendered bid proposal of Philippine Global Communications Inc. to undergo Post-Qualification process for being evaluated and considered as the Lowest Calculated Bid (SCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. WHEREAS, the Committee issued a letter to Philippine Global Communications Inc., dated 22 October 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as *Annex "I"*;



WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 28 November 2024 and presented it to the BAC Committee (Bravo) on 29 November 2024, wherein the BAC-TWG (Bravo) recommended that the bid proposal of **Philippine Global Communications Inc.** be **Post-Disqualified** for their failure to disclose the following contracts a) Renewal of Contract for the Cloud Hosting Services for CAAP Frontline Mission Critical Web Application and b) Internet Access Service Agreement with the Authority in its ongoing Government Contracts wherein its non-disclosure is a ground for disqualification under ITB Clause 10.1 of the Bid Documents and for **Converge ICT Solutions** to undergo **Post-Qualification** for being evaluated as the **Second Lowest Calculated Bid (sLCB)** in the amount of **One Million Two Hundred Twenty-Six Thousand Seven Hundred Eighty-One Pesos (PHP1,226,781.00)**. The copy of said Report and Minutes of Meeting are hereto attached as *Annexes "J" & "K", respectively*;

WHEREAS, the Committee issued a letter to Converge ICT Solutions., dated 29 November 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as *Annex "L"*;

WHEREAS, the Committee issued a Notice of Post-Disqualification to Philippine Global Communications Inc. dated 02 December 2024. A copy of the Notice of Post-Disqualification is hereto attached as *Annex "M"*;

WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 16 December 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC-TWG (Bravo) recommended that the bid proposal of **Converge ICT Solutions.** be declared as **Lowest Calculated Responsive Bid (LCRB)** and that the contract be awarded to the bidder in the amount of **One Million Two Hundred Twenty-Six Thousand Seven Hundred Eighty-One Pesos (PHP1,226,781.00)**. The copy of said Report and Minutes of Meeting are hereto attached as *Annexes "N" & "O", respectively*;

WHEREAS, the BAC TWG-Bravo recommended for the award of the project **Converge ICT Solutions.**, in the amount of **One Million Two Hundred Twenty-Six Thousand Seven Hundred Eighty-One Pesos (PHP1,226,781.00)**.

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.*;

NOW THEREFORE, premises considered, the **CAAP-BAC (Bravo)**, acting upon the recommendation of BAC-TWG (Bravo), hereby **RESOLVES** to **APPROVE** and **AWARD** of the project, Supply, Delivery, Installation and Commissioning of 300 MBPS Dedicated Leased-Line Internet Service for CAAP Head Office, in the amount of **One Million Two Hundred Twenty-Six Thousand Seven Hundred Eighty-One Pesos (PHP1,226,781.00)** to **Converge ICT Solutions.**
