SUBJECT:

RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED SUPPLY, DELIVERY AND INSTALLATION OF COMMERCIAL AIR CONDITIONING UNITS/SYSTEM AT THE CIVIL AVIATION TRAINING CENTER

WHEREAS, the project Supply, Delivery, and Installation of Commercial Air Conditioning Units/System at the Civil Aviation Training Center, an ODG-CATC project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to One Million Forty Thousand Pesos (**Php 1,040,000.00**). A copy of the Certificate of Budget Allocation (C.O) # 24-05-593 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement was on 30 August 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) was posted on 24 September 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, Pre-bid Conference was conducted on 02 October 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, Bid Bulletin No. 01 was issued dated 09 October 2024 re-scheduling the Submission and Opening of Bids. A copy of Bid Bulletin No.01 is hereto attached as *Annex "E"*;

WHEREAS, Bid Bulletin No. 02 was issued dated 02 October 2024 for some clarifications/revisions/amendments in the Bidding Documents. A copy of Bid Bulletin No.02 is hereto attached as *Annex "F"*;

WHEREAS, a notice of Postponement was issued dated 25 October 2024 suspending all BAC proceedings scheduled due to inclement weather. A copy of the Notice of Postponement is hereto attached as *Annex "G"*;

WHEREAS, on 28 October 2024, during the Submission and Opening of Bids at the BAC Bravo meeting, the BAC members and TWG declared a bidding failure under Section 35.1 (a) of the Revised Implementing Rules and Regulations of Republic Act 9184, considering that no bidders submitted their bid. A copy of the Minutes of Meeting is hereto attached as *Annex "H"*;

WHEREAS, Section 35.1 (a) of the Revised Implementing Rules and Regulations of RA 9184 provides that: "The BAC shall declare the bidding a failure when no bids are received";

NOW THEREFORE, the CAAP-BAC BRAVO acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby **RESOLVED** to recommend that the project, **Supply**,
