SUBJECT:

RECOMMENDING THE AWARD OF THE PROJECT ENTITLED, SUPPLY, DELIVERY AND INSTALLATION OF COMMERCIAL AIR-CONDITIONING UNITS/SYSTEM AT THE CIVIL AVIATION TRAINING CENTER (RE-BID)

WHEREAS, in a BAC Resolution No. 2024-0910-228 dated 25 November 2024, The Bids and Awards Committee- Bravo declared the bidding for the project a failure. A copy of BAC Resolution No. 2024-0910-228 is herein attached and made an integral part of this Resolution as Annex "A":

WHEREAS, the Pre-Procurement Conference was conducted on 30 August 2024 via inperson meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as Annex "B";

WHEREAS, the Invitation to Bid (ITB) was posted on 30 October 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as Annex "C";

WHEREAS, Bid Bulletin No. 01 dated 04 November 2024 was issued for some clarification/revision/amendments in the bidding documents of the project. A copy of Bid Bulletin No. 01 is hereto attached as Annex "D";

WHEREAS, the Pre-bid Conference was conducted on 06 November 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as Annex "E";

WHEREAS, the Submission and Opening of bids for the project was held on 18 November 2024 at the CAAP Conference Room via in-person meeting and video conference. A lone bidder submitted their bid proposal for the project and the following results were noted. The copies of the Minutes of the Meeting and Abstract of Bids as read are hereto attached as Annexes "F" & "G", respectively;

WHEREAS, the BAC Technical Working Group (Bravo) issued its Bid Evaluation Report, dated 18 November 2024, and presented it to the BAC on 20 November 2024, indicating that the tendered bid proposal of MJL Enterprises. should undergo the post-qualification process for being evaluated and considered as the Single Calculated Bid (SCB). The copies of said Report and Minutes of Meeting are hereto attached as Annexes "H" & "I", respectively;

WHEREAS, the Committee issued a letter to MJL Enterprises., dated 22 November 2024, requiring them to submit the requirements for post-qualification. A copy of the letter is hereto attached as Annex "J";

WHEREAS, the BAC TWG (Bravo) issued its Post-Qualification Report, dated 05 December 2024, and presented it to the BAC Committee (Bravo) on 09 December 2024, wherein the BAC TWG (Bravo) recommended that the bid proposal of MJL Enterprises. be declared as the Single Calculated Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of Eight Hundred Forty-Six Thousand Eight Hundred Eighty-Nine Pesos & 40/100 (Php 846,889.40). The copies of said Report and Minutes of Meeting are hereto attached as Annexes "K" & "L", respectively;

WHEREAS, Section 37.1.1 of the 2016 IRR of RA 9184 provides that: The BAC shall recommend to the HoPE the award of the contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed;

NOW, THEREFORE, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of the BAC-TWG (Bravo), hereby RESOLVES to RECOMMEND TO AWARD THE CONTRACT for the project Supply, Delivery and Installation of Commercial Air-Conditioning Units/System at the Civil Aviation Training Center (Re-Bid) in the amount of Eight Hundred Forty-Six Thousand Eight Hundred Eighty-Nine Pesos & 40/100 (Php 846,889.40) to MJL Enterprises.
