



**CCC Resolution No. 2024-113**

**SUBJECT: SUPPLY AND DELIVERY OF AIRFIELD LIGHTING SYSTEM SPARE PARTS FOR BICOL INTERNATIONAL AIRPORT.**

**WHEREAS**, Purchase Request/POW/CBA No. 24-08-1078 dated 27 August 2024 for the Supply and Delivery of Airfield Lighting System spare parts for Bicol International Airport with a total budget of P237,345.02 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

**WHEREAS**, on 08 November 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, *"Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR"*. **WHEREAS**, BAC Resolution No. 2024-0910-183 dated 20 September 2024 was signed for the change of mode of procurement. Copy of the Resolution hereto attached as **Annex C**;

**WHEREAS**, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 16 November 2024, Copy of PhilGeps postings hereto attached as **Annex D**;

**WHEREAS**, the Request for Quotation (RFQ) was sent to the following:

**WHEREAS**, Annex "H" of the Revised IRR of RA 9184, states, "*Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation.*"

**NOW, THEREFORE**, in consideration of the above premises, the CAAP-CCC **RESOLVES**, as it is hereby RESOLVED to recommend for **APPROVAL** the Supply and Delivery of Airfield Lighting System spare parts for Bicol International Airport in the total amount of **ONE HUNDRED NINETY-EIGHT THOUSAND NINE HUNDRED FIFTY PESOS (P198,950.00)** only, and be **AWARDED** to **GOLDICHI INDUSTRIAL TRADE**, the offer of which was considered reasonable and advantageous to the Government;
