



BAC Resolution No. 2024-0910-288 (Bravo)

SUBJECT:

RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SUPPLY AND DELIVERY OF DIESEL FUEL FOR DIESEL ENGINE GENERATOR SETS (DEGS) OF VARIOUS NCR FACILITIES (CAAP CENTRAL OFFICE, NAIA-1 RADAR, MANILA TRANSMITTER STATION, AND TAGAYTAY RADAR

FACILITY)

WHEREAS, the project Supply and Delivery of Diesel Fuel for Diesel Engine Generator Sets (DEGS) of Various NCR Facilities (CAAP Central Office, NAIA-1 Radar, Manila Transmitter Station, and Tagaytay Radar Facility), an ANS project, was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to **One Million Nine Hundred Four Thousand Pesos** (**PHP1,904,000.00**). A copy of the Certificate of Budget Allocation CBA (MOOE) NO.: 24-09-1186 dated 18 September 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 28 October 2024 via inperson meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 12 November 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

WHEREAS, the Pre-bid Conference was conducted on 22 November 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 06 December 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted its bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "E" & "F"*, respectively;

WHEREAS, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 09 December 2024 and was presented to the BAC on the same date, where it is indicated that the tendered bid proposal of Absolute Advantage Trading and General Services Inc. to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. WHEREAS, the Committee issued a letter to Absolute Advantage Trading and General Services Inc., dated 09 December 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as Annex "I";


WHEREAS, the BAC-TWG (Bravo) issued its Post-Qualification Report dated 23 December 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC-TWG (Bravo) recommended that the bid proposal of Absolute Advantage Trading and General Services Inc. be declared as Single Calculated Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of One Million Seven Hundred Ninety-Four Thousand Pesos (PHP1,794,000.00). The copy of said Report and Minutes of Meeting are hereto attached as Annexes "J" & "K", respectively.;

WHEREAS, the BAC TWG-Bravo recommended for the award of the project to Absolute Advantage Trading and General Services Inc., in the amount of One Million Seven Hundred Ninety-Four Thousand Pesos (PHP1,794,000.00).

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;

NOW THEREFORE, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of BAC-TWG (Bravo), hereby RESOLVES to APPROVE and AWARD of the project, Supply and Delivery of Diesel Fuel for Diesel Engine Generator Sets (DEGS) of Various NCR Facilities (CAAP Central Office, NAIA-1 Radar, Manila Transmitter Station, and Tagaytay Radar Facility) in the amount of One Million Seven Hundred Ninety-Four Thousand Pesos (PHP1,794,000.00) to Absolute Advantage Trading and General Services Inc.
